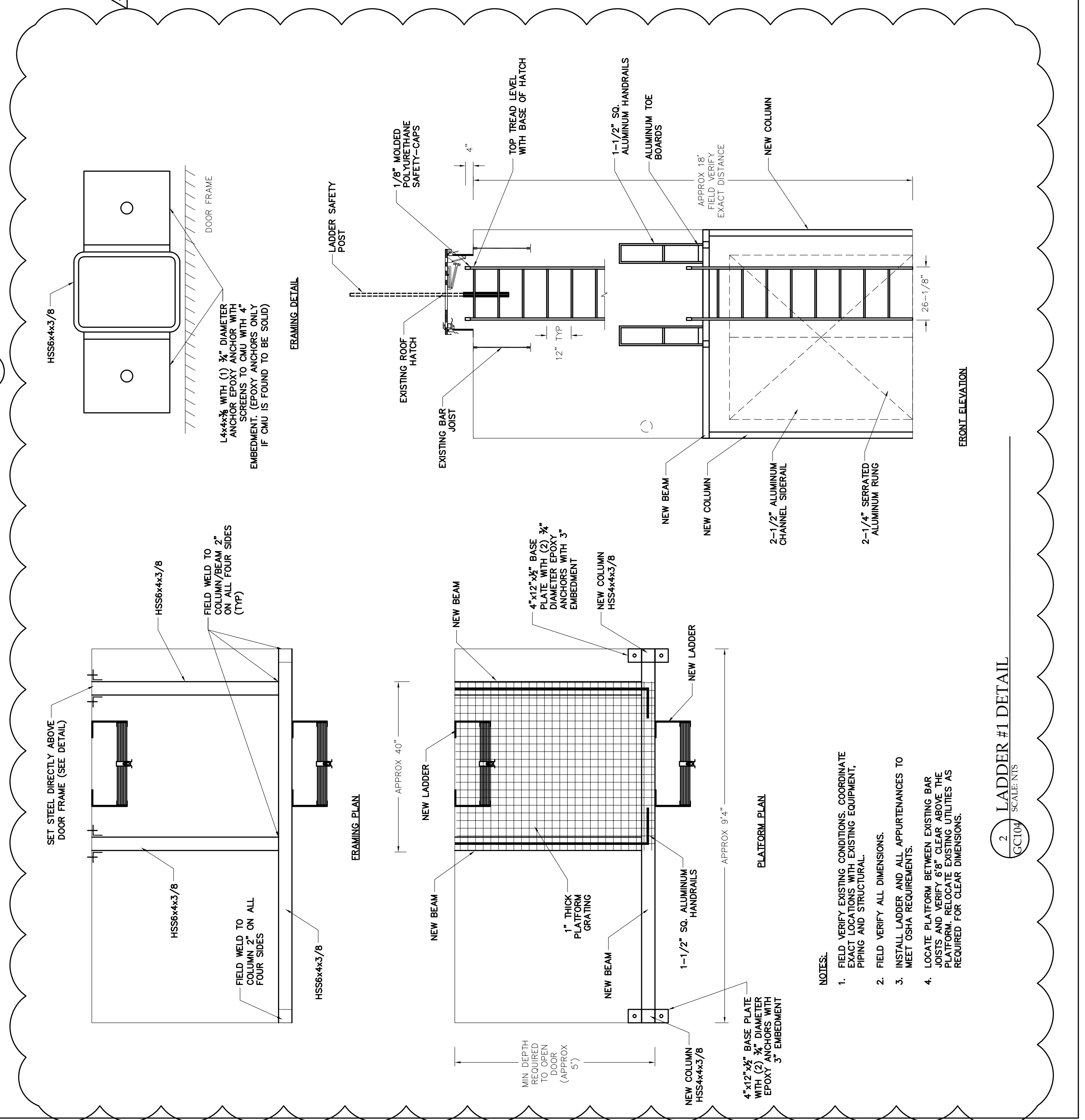

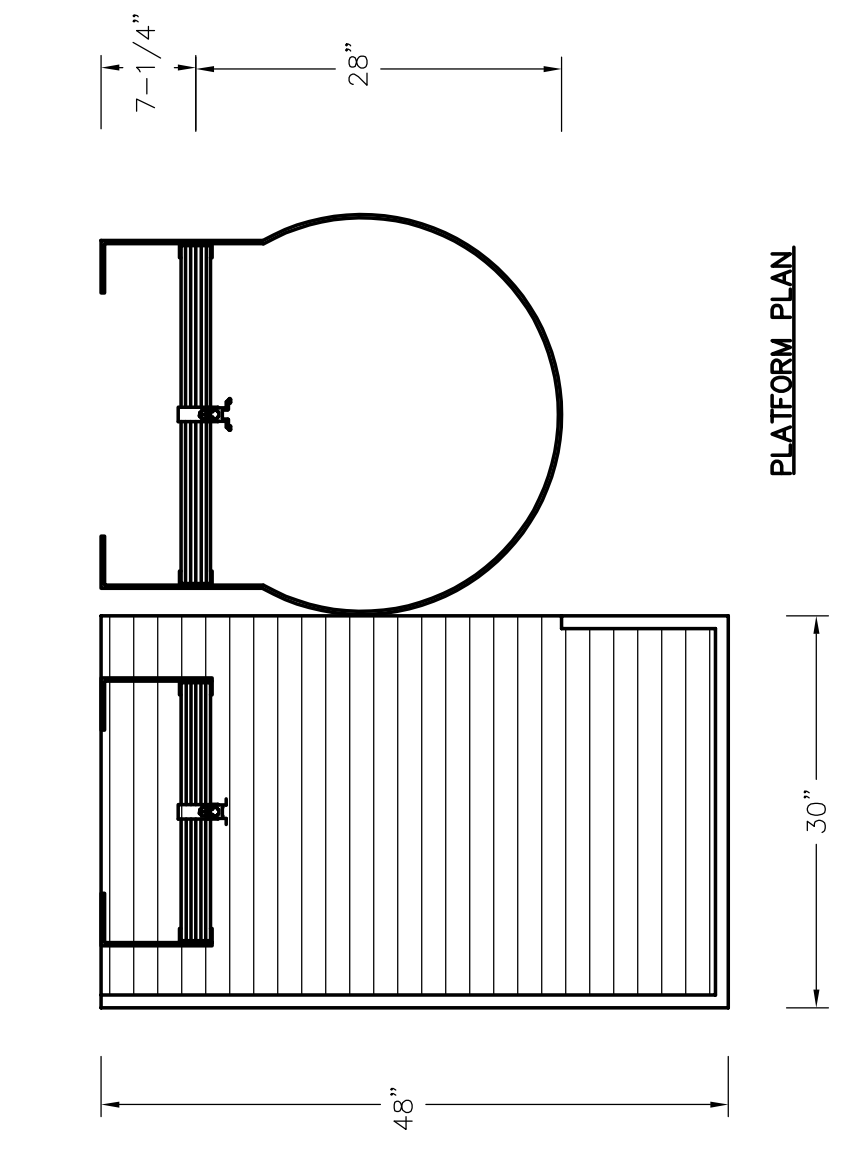
**1 LADDER REPLACEMENT PLAN**

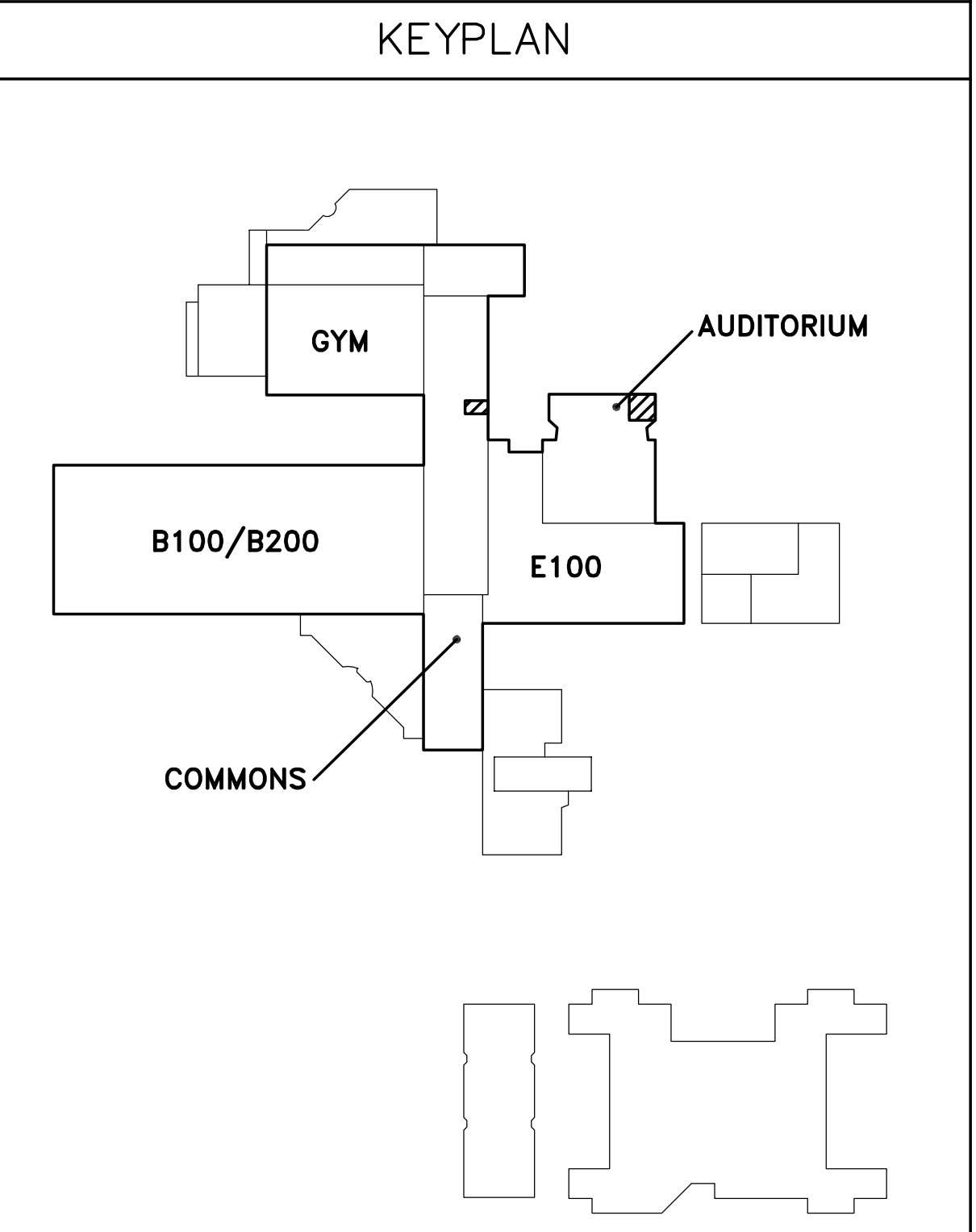
