

1	Based on the flammability concerns surrounding Acrylic per the memorandum set forth by the NYSED [New York State Education Department], would the KSK Public Schools be open to substitute material, specifically, PETG [Poly-Ethylene Terephthalate Glycol]?		
KCKPS	Substitution of materials is acceptable, but not required. The District is looking for a solution that will fit and be stable on student desks.		
2	Can the foldable feature be accomplished using a hinge? The image does not show a hinge.		
KCKPS	Hinges are preferred, as we want to avoid bending of the panels and recoil.		
3	Is a handle required?		
KCKPS	No. A handle is not required.		
4	If awarded, when will the PO submitted?		
KCKPS	It is anticipated that the recommendation for approval of the bid results will be presented to Board of Education, at the scheduled board meeting August 11, 2020. If approved, the purchase		
5	order will be issued August 12 or 13.		
KCKPS	What are the expected delivery dates? The first 9 weeks of the current school year will be virtual learning. Students are currently set to return to in-person learning (in school) by around November 11, 2020. Our preference is to
