The City of Dublin is accepting sealed proposals for the purchase of a **trailer-mounted sewer rodder** for use in the Water Construction Department. All equipment furnished must be new and unused.

- Proposals received after the specified date and time will not be considered. All proposals submitted must be FOB Dublin, Georgia.
- Supporting manufacturer's literature must be provided with proposal.
- The City reserves the right to accept or reject any or all proposals, to waive formalities and technicalities, and to make an award in the best interest of the City.
- The City of Dublin is exempt from Federal Excise and State Sales taxes.
- All bidders must be recognized and authorized dealers in the materials or equipment specified and be qualified to advise in their application or use. A bidder at any time requested must satisfy the Purchasing Office and City Council that he has the requisite organization, capital, plant, stock, ability and experience to satisfactorily execute the contract in accordance with the provisions of the contract in which he is interested.
- Reference to brand or trade names are for comparative purposes only. Proposers may submit proposals on items from other manufacturers. In these instances, proposals shall be accompanied with all descriptive information necessary for a thorough evaluation. Failure to provide supporting data shall be cause for rejection.

- Factors to be considered in making this award, if awarded, will be equipment, price, service locations, warranty and references. The City will be the sole judge of the weights given these factors.
- Proposals will be opened in the conference room in the Purchasing Department, 702 E. Madison St., Dublin, Georgia, on the hour and date specified above, local time prevailing. No proposals will be accepted after the opening time. No faxed or e-mailed proposals will be accepted.
- Prices quoted shall be firm prices and remain firm until delivery is made. If awarded, the City will place an order with the successful bidder within forty-five (45) days after opening.
- Payment terms are N30 unless otherwise stated in the proposal.

The City of Dublin reserves the right to negotiate with any vendor to obtain the best value for the City.
