The District reserves the right to split the award or to make multiple awards, and to make award on a part or portion of a quote. Only quotes complying with the following specifications/terms will be considered.

- 1. One (1) electronic copy of the quote documents shall be submitted using the two (2) attached Exhibit-A and Exhibit-B forms, which shall be submitted via email as indicated above and received no later than **5:00 PM on Tuesday, January 9, 2024**.
- 2. Preference will be given to quotes for the specified makes and models. Only current-model substitutions for listed instruments will be considered.
- 3. Quoted prices should include delivery of instruments to Lafayette High School located at 17050 Clayton Road, Wildwood, Missouri 63011. An estimated delivery timeline and product warranty information should be included as part of your quote. Instruments will be awarded by line item.
- 4. Quotes for marching band instruments must include a playtest and adjustment, as necessary, which must be performed prior to delivery, and cased for each as per RFQ. Instrument quotes to be drop shipped from the manufacturer will not be accepted.
- 5. Quoted prices shall remain in effect through June 30, 2024.
- 6. All quotes should include the name, title, mailing address, telephone number and email address of the contact person submitting the quote.
- 7. Vendor must be capable of accepting a purchase order from Rockwood School District.
- 8. This is a tax-exempt purchase with Net 45 payment terms.

A recommendation to purchase will be submitted to the district's Board of Education on February 1, 2024. Related purchase orders(s) will be issued February 2, 2024.
