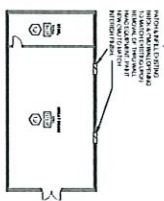
1.1 FLOOR PLAN - MULTIPURPOSE BUILDING



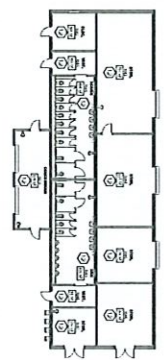
1.2 FLOOR PLAN - UPPER LEVEL - FIELD HOUSE SOUTH



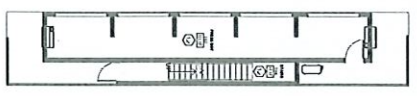
1.3 FLOOR PLAN - LOWER LEVEL - FIELD HOUSE SOUTH



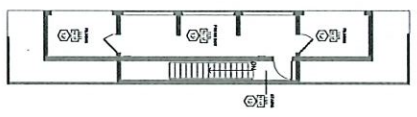
1.4 FLOOR PLAN - R.O.T.C. BUILDING



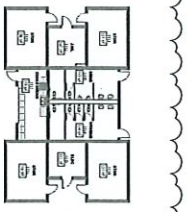
1.5 FLOOR PLAN - FIELD HOUSE NORTH



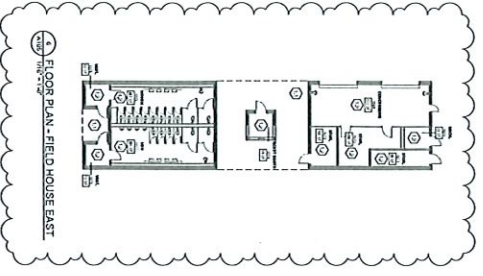
1.6 FLOOR PLAN - PRESS BOX - LEVEL 1

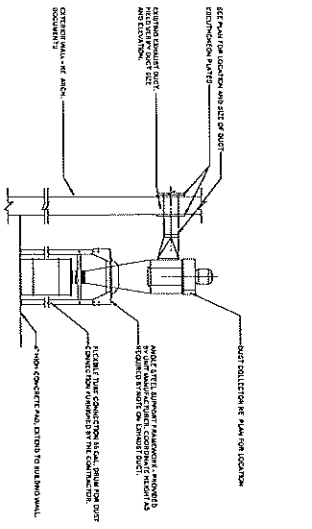
2 AIR HANDLING UNIT W/ WHEEL, IN MECH. RM. DETAIL



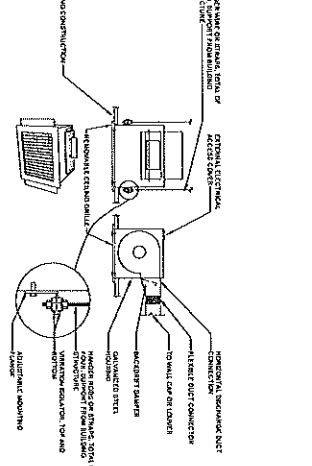

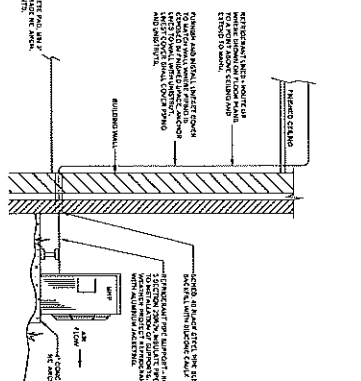
