Alternate brand name items offered for bid must be equivalent as to function, basic design, type and quality of material, method of construction, and any required dimensions. Bidder must attach a letter of exception to specifications.

# STATE OF TENNESSEE IRAN DIVESTMENT ACT AGREEMENT
