Please be advised of the following changes to the subject Two-Step Invitation for Bid:

- 1. The time and date for the submittal of qualifications submittals remains: 2:00 p.m., July 19, 2022.
- 2. The time and date for the receipt of competitive sealed bids remains: 2:00 p.m., August 12, 2022.
- 3. A digital recording of the Pre-Bid Conference is available upon request.
- 4. A list of firms attending the Mandatory Pre-Bid Conference on July 6, 2022, is attached. The District will only accept bids from the firms that attended the mandatory pre-bid conference.
- 5. Additional information regarding the project will be provided in a future addendum.
- 6. Please be advised of the following information regarding work on Camp Blanding:

# **Unexploded Ordinance (UXO) Requirements Camp Blanding Lands**

The Successful Respondent must have at least one UXO trained individual on site, during all activity that occurs on Camp Blanding property. This is generally defined as anything on or behind the Camp Blanding fence line (field fencing) that limits access between the FDOT right-of-way and Camp Blanding. Additionally, all of Treat Road is on Camp Blanding land and the presence of a UXO trained individual is required for any work along Treat Road, irrespective of the presence of field fencing or not. UXO training will be provided by Camp Blanding staff at no cost to the Successful Respondent. The training shall be scheduled with Camp Blanding conservation manager, Matt Corby at (904) 626-8572. The training is only required once per individual. The District strongly encourages the Successful Respondent to obtain the training for multiple members of its staff. If any of the Successful Respondent's staff changes during the contract term, training for the new individuals shall be required. The Successful Respondent will coordinate the additional training with the Camp Blanding's conservation manager.

 Addendum 2 deleted and replaced Paragraph 8. MINIMUM QUALIFICATIONS on Page 7 of the Bid Documents. <u>Delete</u> Paragraph 8. MINIMUM QUALIFICATIONS added under Addendum 2 in its entirety and <u>replace</u> it with Paragraph 8. MINIMUM QUALIFICATIONS below:

# **"8. MINIMUM QUALIFICATIONS**

Respondent must use the "Qualification" forms (General, Similar Projects, and Client References) provided in these documents to document the minimum qualifications listed below. If Respondent fails to include these forms and the Respondent-provided documentation requested below with the Bid, Respondent's Bid may be considered non-responsive.

- a. Respondent (or a combination of the firm or project manager assigned to the work) must have **successfully completed** at least <u>two</u> projects of a similar nature (water or wastewater transmission line) prior to the date for receipt of Qualification Submittals.
  - 1. One of the Similar Projects must include a minimum of eight miles of 16" or larger ductile iron, HDPE, PVC or steel pipe.
  - 2. The second Similar Project must include a minimum of eight miles of 16" or larger <u>ductile iron or PVC pipe</u>.
  - 3. Each Similar Project cited must have had a project value of at least \$10,000,000.
  - 4. Respondent must have performed a minimum of 50% of the work with its employees on each Similar Project.
  - 5. For each Similar Project cited, Respondent is responsible to provide all the information requested. Respondent is cautioned to ensure that the contact information (names, email addresses, and phone numbers) is correct, and that the proposed contact is amenable to speak with District representatives and/or respond to a written inquiry. The District will contact the individuals named to verify the similar project information as it relates to this solicitation. If the information provided by Respondent is not of a similar nature, cannot be verified by the District, or the proposed contact person fails to respond to the District's inquiry, Respondent's bid may be considered non-responsive.

- b. Respondent (or a combination of the firm or project manager assigned to the work) must have successfully completed at least <u>one</u> project of a similar nature (water or wastewater transmission line) prior to the date for receipt of Qualification Submittals that include both items 8.b.1 and 8.b.2. OR at least <u>two</u> projects of a similar nature (water or wastewater transmission line) prior to the date for receipt of Qualification Submittals: one project for item 8.b.1 and another project for item 8.b.2.
  - 1. At least one of the two projects must have included a jack and bore crossing under a utility line, roadway, railroad, or waterbody) for a minimum 16" diameter carrier pipe.
  - 2. At least one of the two projects must have included a horizontal directional drill crossing under a utility line, roadway, railroad, or waterbody) for a minimum 16" diameter carrier pipe.

c. Respondent shall currently employ both a Florida Licensed General Contractor **OR** a Florida Licensed Underground Utility Contractor who shall serve as Respondent's qualifying agents and who shall have at least <u>four</u> years of experience on projects of the nature specified under subparagraph (a) above.

d. Respondent must provide three client references. Up to two of the client references may be from the similar projects listed in response to subparagraph (a), above. For each client reference cited, Respondent is responsible to provide all the information requested. Respondent is cautioned to ensure that the contact information (names, email addresses, and phone numbers) is correct, and that the proposed contact is amenable to speak with District representatives and/or respond to a written inquiry. The District will contact the references to verify the information as it relates to this solicitation. If the information provided by Respondent cannot be verified by the District, or the proposed contact person fails to respond to the District's inquiry, Respondent's bid may be considered non-responsive.

Irrespective of the minimum qualifications stated above, the District may make such investigations as it deems necessary to determine the ability of the Respondent to perform the Work. The District reserves the right to reject any Bid if the evidence submitted by such Respondent and/or the District's independent investigation of such Respondent fails to satisfy the District that such Respondent is properly qualified to carry out the obligations of the Agreement and complete the Work in a manner acceptable to the District within the time-period specified."
