

## INVITATION TO BID – PROJECT SPECIFIC CONSTRUCTION SERVICES

The City of Daytona Beach will receive bids for the **SWEETHEART TRAIL - BALLOUGH ROAD BRIDGE REBID, Invitation to Bid No. 20063**, at the City of Daytona Beach Purchasing Division, City Hall Room 146, 301 S. Ridgewood Ave., Daytona Beach, Florida 32114, until **2:00 p.m., October 28, 2019**, at which time bids will be opened publicly and read aloud. Bids received after said time will be returned unopened.

**The work** limits are along Ballough Road, from the south side of Anita Avenue to the north side of Root Street, approximately 0.18 miles in length. The project consists of re-stripping Ballough Road to provide a 10 to 11-foot-wide shared used path with a 5-foot buffer. The existing on-street parking will be eliminated and the existing travel lanes will be shifted to accommodate the shared use path along the east side of Ballough Road. Additional improvements include mobilization, maintenance of traffic, clearing and grubbing, excavation, signing, striping, delineators, detectable warning surfaces, and curb ramps. All pedestrian facilities shall adhere to current ADA standards.

**Each bid** must be accompanied by **Bid Security** in an amount not less than 10% of the total bid.

**ANON-MANDATORY PRE-PROPOSAL CONFERENCE** will be held at the Daytona Beach Public Works, 950 Bellevue Avenue #500, Daytona Beach, Florida 32114, on 10/21/2019 at 10:00 AM. Interested contractors are *urged* to attend.

**The successful contractor** will be required to furnish separate 100% Performance and Payment Bonds unless the Contract price is less than \$100,000.

**The City** reserves the right to reject any and all bids, or any portion of any bid, or to waive any informalities in the bidding.

**Bids may be held** by the City for a period not to exceed 60 days from the date of opening of bids for the purpose of reviewing the bid and investigating the qualifications of bidders prior to awarding the contract.
