## ADVERTISEMENT FOR COMPETITIVE SEALED BIDS

Separate sealed Bids for the construction of **Upper Flint / Lake Mirror Stormwater Improvements Phase I** will be received by the Clayton County Water Authority at 1600 Battle Creek Road, Morrow, Georgia 30260 until **2:00 p.m. local time, the 2nd day of December, 2014**, and then at said office publicly opened and read aloud. Any bids received after the specified time will not be considered.

A non-mandatory pre-bid conference will be held at the Clayton County Water Authority, 1600 Battle Creek Road, Morrow, Georgia 30260 on **November 13, 2014 at 2:00 p.m. local time**, to discuss the Project. A site visit is mandatory. Bidders are encouraged to attend the pre-bid conference, however attendance is not mandatory. A bid submitted by a Bidder who did not visit the site while being escorted by the Owner's staff will not be opened.

The Project generally consists of 700 feet of 60-inch and 20 feet of 48-inch reinforced concrete pipe storm sewer, including 7 precast concrete drainage structures, pavement removal and replacement, and erosion and sedimentation control.

The Bidding Documents, consisting of Advertisement for Competitive Sealed Bid, Instructions to Bidders, Bid Form, Bid Bond, Construction Contract, Performance Bond, Payment Bond, General and Supplementary Conditions, Specifications, Drawings, and Addenda may be examined at the main offices of the Owner at 1600 Battle Creek Road, Morrow, Georgia. Bidding documents may be obtained from Jacobs Engineering Group Inc., 6801 Governors Lake Parkway, Building 200, Norcross, Georgia 30071, upon payment of \$150.00, non-refundable, for each set of Documents. Prices include sales tax and two-day shipping. Return of the documents is not required.

Each Bid must be submitted on the prescribed Bid Form and accompanied by Bid Security as prescribed in the Instructions to Bidders, payable to the Owner in an amount not less than 5 percent of the amount Bid.

In order to perform public work, Bidder and its subcontractors, prior to award of Contract, shall hold or obtain such licenses as required by state statutes, and federal and local laws and regulations.

Owner's right is reserved to reject all Bids or any Bid not conforming to the intent and purpose of the Bidding Documents.
