General Project Description:

The project consists of the construction of a 1-story, indoor aquatic center and associated site work located at the intersection of Rehoboth & Barrow roads in Griffin, Georgia. The project includes all work shown on the drawings and specifications to include, but not be limited to, the following items:

- A 20,750 sq. f.t indoor aquatic center with an 8-lane x 25-yard competition pool with a diving board and a 4-lane x 25-yard therapy/instructional pool.
