Marion Avenue, Lake City, FL 32055 until **11:00 AM, EDT, on Thursday, July 16, 2020** and there, at said office, at said time, publicly opened and read aloud. An original and one copy, **BOTH CLEARLY MARKED ITB-021-2020** shall be submitted in a sealed envelope.

**The project includes new LED edge lighting system along Runway 5-23, Taxiway E & D and Taxiway A1. Installation and equipment include new lights (cans and fixtures), directional boring, conduit, airfield cable, counterpoise, junction cans and constant current regulator.**

Each bid must be accompanied by a certified check or bid bond, in the amount of five percent (5%) of the total maximum bid price (combination of base bid or alternate bid plus add-on items) for the contract in the form and subject to the conditions provided in the Preparation of Proposal.
