2. Answers to Bidders' written questions:

Q1 – Will the scope of services require field visits to all 140 public lift stations? **A1** – The intent of this Wastewater Master Plan is to evaluate the age and capacity of existing wastewater infrastructure to maintain the current level of service while planning for future growth. The project scope will be finalized in more detail once a Consultant is selected. During the final scope composition, the City intends to identify lift stations that are known to need upgrades due to age or capacity. The Consultant, including civil, structural and/or electrical engineers, as required, may need to visit these stations during the infrastructure evaluation. It is not the City's intent to have a site visit to every public lift station. Upgrades required to the wastewater treatment plants as a result of increased flow may also warrant a site visit to the facilities.

Q2 – Do you intend for the scope of services to include pipeline video inspection?

A2 – The City does not intend for this project to include pipeline video inspection. The City intends to provide the Consultant information regarding known areas with inflow and infiltration concerns.

- Q3 Does the City have an existing wastewater hydraulic model?
- A3 Yes, the City currently utilizes ForceMain for hydraulic modeling. The City is interested in an evaluation of available hydraulic modeling software to determine which product would best meet the City's needs. The City may require training in the hydraulic modeling software as part of the final scope of services.
- **Q4** Criteria 3 and 4 require information regarding previous Wastewater Master Plans from the proposed project manager. Can these Wastewater Master Plans be from a previous employer?
- **A4** Yes, the intent is to evaluate the project manager's quality of work. The executive summaries can be from a previous employer as long as the 3 mandatory requirements outlined in Criterion 3 are met.
- 3. All other terms and conditions remain the same.

The Bidder/Proposer shall acknowledge receipt of this addendum in the transmittal letter covering their proposal.
