Curry County has previously issued an Invitation to Bid #2020/21-03 for Diesel and Unleaded Fuel for the Curry County Road Department. That Invitation to Bid has rescinded and canceled and Curry County is issuing this new Invitation to Bid.

On behalf of the Board of Curry County Commissioners and pursuant to and in compliance with the NM State Procurement Code, Curry County hereby invites competitive sealed bids for the purchasing of No. 2 Low Sulfur Undyed Diesel Fuel and Unleaded Fuel with an octane rating of 87 plus in Bulk for road use by the Curry County Road Department.

1. **Criteria for Award:** Award shall be based on the lowest responsible bid prices which meet specifications. Award will be made to the bidder who provides the overall lowest cost for both Undyed Diesel and Unleaded fuel. The Board of Curry County Commissioners reserves the right to reject any or all bids, to waive any technicalities and to accept the bid(s) which in its judgment is most advantageous to the County.
2. **Guaranteed Performance:** The successful bidder, if awarded a contract as a result of this bid, guarantees that services will conform to the specifications in this bid. Failure of the bidder to comply with providing a service which meets minimum specifications may result in termination of the award of that item or termination of the contract.

SPECIFICATIONS

Curry County is requesting bids for the purchasing of No. 2 Low Sulfur Undyed Diesel Fuel and Unleaded Fuel with an octane rating of 87 plus in Bulk for road use by the Curry County Road Department. The fuel must be winterized during the cold months at no additional cost. The price must be F.O.B the Curry County Road Barns at Clovis, Melrose and Broadview. The bidder must be able to provide both Undyed Diesel and Unleaded fuel to be considered responsive.

The following are the minimum specifications for Bulk Undyed Diesel:

No. 2 Undyed Diesel fuel, Ultra-Low Sulphur Diesel (ULSD), with a minimum cetane number of 40, maximum of 0.05 weight percent of Sulphur, maximum aromatic content of 35 volume percent, viscosity of min. 1.9 and max 4.01, distillation of min 282 and max. of 338, carbon residue of 0.35 approx. Cloud of -20 degree Celsius and max of -40 degree Celsius.

Diesel fuels shall be free from contamination.

Fuel quantity shall be measured by the gross gallon, with a metered delivery truck bearing a current New Mexico Department of Agriculture approval seal.

Not using metered trucks may constitute grounds for termination of the agreement.

Deliveries of diesel fuel are expected to occur every Tuesday and Thursday, or as needed by the Road Department and made within forty-eight (48) hours after receipt of order (phone or written), excluding Saturdays and Sundays, as well as State and federal holidays observed by the ordering agency.

All prices shall be F.O.B. Destination to the delivery locations designated by Curry County. Awarded bidder shall retain title and control of goods until they are delivered and the contract coverage has been completed. All risk of transportation and all related charges shall be the responsibility of the bidder.

Current diesel delivery locations and number of tanks are:

Clovis - 1006, Curry Road 6, Two (2) 1000-gallon tanks

Anticipated yearly gallons of diesel to be purchased range from 55,000 to 70,000 per year. Anticipated estimates are based on previous usage and are not guaranteed throughout the life of the agreement.

The awarded bidder shall be responsible for all spillage which may occur during transit and unloading operations. The awarded bidder shall immediately report spillage to the ordering office and clean up the spillage according to EPA and state guidelines and requirements. After contamination is discovered, the awarded bidder shall be responsible for the removal of the fuel(s) on County's property within Twenty-Four (24) hours. The awarded bidder shall also be responsible for all cleanup required to all County's property, storage facilities, and equipment as a result of noncompliance with specifications. Furthermore, the awarded bidder shall be fully responsible for any and all costs incurred by the County for any equipment sustaining damage, which is attributed to a contaminated fuel(s), which the vendor has delivered.

Curry County is exempt from paying Federal excise taxes on fuel and shall not reimburse the awarded bidder for any such expenses. Federal excise taxes shall be the sole responsibility of the awarded bidder.

Price(s) bid shall be on a Per Gallon delivered price. Bidder's mark-up price shall include all bidders' costs.

Unleaded Fuel with an octane rating of 87 plus.

Unleaded fuels shall be free from contamination.

Fuel quantity shall be measured by the gross gallon, with a metered delivery truck bearing a current New Mexico Department of Agriculture approval seal.

Not using metered trucks may constitute grounds for termination of the agreement.

Deliveries of unleaded fuel are expected to occur once a week either on Tuesday or Thursday, or as needed by the Road Department and made within forty-eight (48) hours after receipt of order (phone or written), excluding Saturdays and Sundays, as well as State and federal holidays observed by the ordering agency.

All prices shall be F.O.B. Destination to the delivery locations designated by Curry County. Awarded bidder shall retain title and control of goods until they are delivered and the contract coverage has been completed. All risk of transportation and all related charges shall be the responsibility of the bidder.

Current unleaded delivery locations and number of tanks are:

Broadview - 3899 SR 209, one (1) 500-gallon tank

Anticipated yearly gallons of unleaded to be purchased range from 2,000 to 4,000 per year. Anticipated estimates are based on previous usage and are not guaranteed throughout the life of the agreement

The awarded bidder shall be responsible for all spillage which may occur during transit and unloading operations. The awarded bidder shall immediately report spillage to the ordering office and clean up the spillage according to EPA and state guidelines and requirements. After contamination is discovered, the awarded bidder shall be responsible for the removal of the fuel(s) on County's property within Twenty-Four (24) hours. The awarded bidder shall also be responsible for all cleanup required to all County's property, storage facilities, and equipment as a result of noncompliance with specifications. The successful bidder must supply the Road Superintendent and the County Finance Department with rack prices electronically on a weekly basis along with copies of fill tickets.

Curry County reserves the right to, at its discretion, test any pumps providing services to County vehicles. The county can perform the test themselves or can hire others to perform testing for the County. In the event that a discrepancy arises, bidder shall take whatever steps are necessary to correct any billing errors.

CONTRACT

The term of a contract awarded as a result of this BID shall be from award date for two (2) years. The contract may be renewed according to the terms stated herein for one (1) additional two (2) year period, not to exceed four (4) years. All prices, costs and conditions submitted in response to this Invitation to Bid shall remain fixed and valid after the closing date for this bid submission and throughout the term of the agreement. The County shall have the option of renewing the existing contract, by mutual agreement, with approval by the Board of Commissioners, or requesting new Bids for services. The rates may be negotiated for each renewal of the contract. A breach of any terms of the contract shall be grounds for immediate termination of the contract. Either party may terminate the contract for any reason upon written notice to the other party, made at least thirty days in advance of the termination date.

VARIATIONS

Any variations from, or exceptions to, the conditions and specifications of this bid must be listed on a separate sheet labeled "Exception(s) to Bid Conditions", and attached to the bid.

QUOTATION SHEETS

Bidders shall use the attached Quotation Sheet(s) to submit their bids. The Quotation Sheet(s) must be signed.

MATERIAL ESCALATION

In the event of a product cost increase, each escalation request must be timely submitted for review to the County Road Superintendent on an individual basis. This measure is not intended to allow any increase in profit margin and is solely intended to allow compensation for actual cost increases directly related to bid items. To facilitate prompt consideration, any request for price increase must include all information listed below: 1. Contract Item Number 2. Current Item Price 3. Proposed New Price 4. Percentage of Increase 5. Mill/Supplier Notification of price increase indicating percentage of increase including justification for increase. The Curry County Road Superintendent upon review of an escalation request may require additional supporting documentation prior to providing a written recommendation to the Board of County Commissioners. The final determination on the approval or disapproval of the escalation request will be made by the Curry County Board of County Commissioners.

NEW MEXICO BIDDER'S PREFERENCE

Pursuant to Sections 13-1-21 & 13-4-2 NMSA 1978, and GSD Rule 1.4.1 NMAC, bidders claiming the 5% preference must be certified prior to the bid opening. The number must appear on the Quotation Sheet(s) in the space provided in order to receive the preference.

RESERVATIONS

The Curry County Commission reserves the right to reject any or all bids, to waive any technicalities, to accept in whole or in part such bid or bids as may be deemed in the best interest of the County.

SAFETY REQUIREMENTS

It shall be the contractor's responsibility to provide for the safety of its workers and the public in compliance with the requirements of insurance and public health and safety standards.

AWARD

The award may be made to the bidder providing a responsive, responsible bid that meets and satisfies all of the requirements herein and results in the lowest overall cost to the

County. The award will be made by the Curry County Commission at their regularly scheduled meeting. Bid prices must be good for ninety (90) days subsequent to date of opening.

GENERAL CONDITIONS

1. Bid Forms: All pages included in this Invitation to Bid that are marked "**BID FORM**" must be completed and submitted as part of the bid document.
2. Bids Binding Ninety (90) days: Unless otherwise specified all formal bids submitted shall be binding for ninety (90) calendar days following bid opening date, unless the bidder(s), upon request of the County Manager, agrees to an extension.
3. Payment Terms: For all goods/services provided by the successful bidder, payment shall be made net thirty (30) days from invoice date after receipt of goods/services unless otherwise specified on bid form or as otherwise agreed by both parties. All invoices shall be submitted directly to the Curry County Finance Department at 417 Gidding, Suite 100, Clovis, NM 88101. The successful bidder must submit and have a completed W9 form on file with the County prior to any payments being issued.

For all services paid by Credit Card, standard payments are usually made within 3-5 business days. All services made by credit card require a receipt. Invoices shall not be submitted separately if payment is made with credit card. Curry County shall not pay any fees when utilizing a credit card for payment.

4. Equivalency: The County hereby reserves the right to approve as equivalent, or to reject as not being equivalent, any item the bidder proposes to furnish which contains variations from specification requirements but may comply substantially therewith. Such decisions are strictly at the discretion of the County.
5. If there is any clarification, problem, ambiguity or question regarding this bid, you must contact the Procurement Officer or designee prior to the bid opening. Clarifications and addenda will be considered prior to the bid opening. Answers provided regarding the bid specifications or bid package **MUST** be answered by the Procurement Officer or designee. Questions answered by any other person or County official shall be considered completely nonapplicable to the legal provisions of this bid, except as specifically authorized by the Procurement Officer.
6. Restrictive Specifications: It is the responsibility of the prospective bidder to review the entire Invitation to Bid (ITB) packet and to notify the purchasing department if the

specifications are formulated in a manner which would unnecessarily restrict competition. Any such protest or question regarding the specifications or bidding procedures must be received in the purchasing department not less than seventy-two (72) hours prior to the time set for bid opening.

7. An in-state resident or resident veteran preference will be given to all resident New Mexico businesses that have been issued certification by the State of New Mexico. To qualify for the preference, the bidder must list a valid resident business certificate number and shall submit a copy of the certificate with the bid. If you have a question regarding a Resident Business (or Resident Veteran Business) Certification, or wish to be given a number, you may contact the New Mexico State Department of Taxation and Revenue at 505-827-0951. This number is valuable to have as it allows the county to consider your bid at five to ten percent less than the amount submitted, and could mean a difference in award. Please note that this number is NOT your State CRS Number (i.e. 01503047004). In addition, **any preference numbers issued by the NM State Purchasing Office were valid only through December 31, 2011 and must be re-issued through the Taxation and Revenue Department.**
8. Bidders shall list on a separate sheet of paper any variations from or exceptions to the conditions and specifications of this bid. **This sheet shall be labeled "Exception(s) to Bid Conditions" and shall be included with bid.**
9. Non-collusion: Bidders, by submitting a signed bid, certify that the accompanying bid or proposal is not the result of, or affected by, any unlawful act of collusion with any other person or company engaged in the same line of business or commerce, or any other fraudulent act punishable under New Mexico or United States law.
10. Non-discrimination Statement: Curry County in accordance with the provisions of Title VI of the Civil Rights Act of 1964 (78 Stat. 252, 42 U.S.C. §§ 2000d to 2000d-4) and the Regulations, hereby notifies all bidders that it will affirmatively ensure that any contract entered into pursuant to this advertisement, disadvantaged business enterprises will be afforded full and fair opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, or national origin in consideration for an award. 11. Qualifications of Bidders: The County Purchasing Officer may make such investigations as he/she deems necessary to determine the ability of the bidder to perform the work, and the bidder shall furnish to the County all such information and data for this purpose as the County may request. The County reserves the right to reject any bid if the evidence submitted by, or investigation of, such bidder fails to satisfy the County that such bidder is properly qualified to carry out the obligations of the contract and to complete the work contemplated therein.

12. The State of New Mexico's Procurement Code, Section 13128 through Section 131199 NMSA 1978, imposes civil and criminal penalties for its violations. In addition, the New Mexico Criminal Statutes impose felony penalties for illegal bribes, gratuities and kickbacks.
13. Curry County reserves the right to reject any bid from a bidder who previously failed to perform properly, or complete on time, contracts of similar nature, or to reject the bid of a bidder who is not in a position to perform such a contract satisfactorily. Such is at the discretion of the County.
14. The successful bidder agrees to protect, defend and save the County, its elected and appointed officials, agents, and employees, while acting within the scope of their duties as such, harmless from and against all claims, demands, causes of action of any kind or character, including the cost of defense thereof, arising in favor of the contractor's employees or third parties on account of bodily or personal injuries, death, or damage to property arising out of services performed or omissions of services or in any way resulting from the acts or omissions of the contractor and/or its agents, employees, representatives, assigns, subcontractors, except the sole negligence of the County under this agreement.
15. If a bidder to whom a bid is awarded refuses to accept the award or, fails to deliver in accordance with the contract terms and conditions, the County may, in its discretion, suspend the bidder/contractor for a period of time from entering into any contracts with Curry County.
16. This solicitation is governed by the laws of the State of New Mexico. By signing and submitting a bid, the parties agree that any litigation concerning this bid, request for proposal, limited solicitation, or subsequent contract or purchase order, must be brought in the Ninth Judicial District in and for Curry County, State of New Mexico, and each party shall pay its own costs and attorney fees.
17. Successful bidder must, in performance of work, agree to fully comply with all applicable federal, state and local laws, rules and regulations. The bidder will be required to carry the following minimum insurance coverage with Curry County named as additional insured on all policies:
 - a. General and professional liability insurance in the amount of \$1,050,000 single limit, and \$2,000,000 aggregate
 - b. Workers' Compensations insurance as required by state statute.
18. It is the responsibility of the bidder to ensure that any addenda issued related to this Invitation to Bid have been received prior to submitting a bid. The County guarantees that any addenda issued will be distributed and available to every party on the Distribution List for this solicitation. The County will not accept responsibility for

CAMPAIGN CONTRIBUTION DISCLOSURE FORM

Pursuant to the Procurement Code, Sections 13-1-28, et seq., NMSA 1978 and NMSA 1978, § 13-1-191.1 (2006), as amended by Laws of 2007, Chapter 234, any prospective contractor seeking to enter into a contract with any state agency or local public body **for professional services, a design and build project delivery system, or the design and installation of measures the primary purpose of which is to conserve natural resources** must file this form with that state agency or local public body. This form must be filed even if the contract qualifies as a small purchase or a sole source contract. The state agency or local public body that procures the services or items of tangible personal property shall indicate on the form the name or names of every applicable public official, if any, for which disclosure is required by a prospective contractor.

The following definitions apply:

“Campaign Contribution” means a gift, subscription, loan, advance or deposit of money or other thing of value, including the estimated value of an in-kind contribution, that is made to or received by an applicable public official or any person authorized to raise, collect or expend

contributions on that official's behalf for the purpose of electing the official to statewide or local office. "Family member" means spouse, father, mother, child, father-in-law, mother-in-law, daughter-in-law or son-in-law of (a) a prospective contractor, if the prospective contractor is a natural person; or (b) an owner of a prospective contractor.

"Pendency of the procurement process" means the time period commencing with the public notice of the request for proposals and ending with the award of the contract or the cancellation of the request for proposals.

"Prospective contractor" means a person or business that is subject to the competitive sealed proposal process set forth in the Procurement Code or is not required to submit a competitive sealed proposal because that person or business qualifies for a sole source or a small purchase contract.

"Representative of a prospective contractor" means an officer or director of a corporation, a member or manager of a limited liability corporation, a partner of a partnership or a trustee of a trust of the prospective contractor.
