The following information shall be incorporated as part of the above mentioned solicitation. All other terms and conditions shall remain the same.

Bid Opening Date and Time

The bid opening date and time has been changed to March 8, 2018 at 2:00 pm.

Solicitation Questions Received

1. **Question:** What are the dimensions of the existing structures for the (4) new scoreboards?
 - a. Width apart = 28 feet
 - b. Height = 8 feet**Answer:** Width apart = 28 feet Height = 8 feet. Contractors are strongly advised to visit the sites to verify measurements.
2. **Question:** Is there existing structure for all (4) new scoreboards, or will any new structure be required? **Answer:** Structures exist. Bidders should visit the sites to determine if existing structures are suitable for installation.
3. **Question:** What size net will be needed? (how wide, how tall)
Answer: The size of the net should be the same size as the scoreboard.
4. **Question:** What size sign are you needing? (how wide, how tall)
Answer: The sign should be the same length as the scoreboard and 3' tall.
5. **Question:** What dimensions are you looking at for your scoreboards? The 3 listed in the solicitation aren't the same size. (How wide, how tall)
 - a. Daktronics scoreboard model # BA-2125 is only 25' wide
 - b. Fairplay scoreboard model # BA-7128 is 28' wide
 - c. Nevco Scoreboard Model # 1604 is 28' wide**Answer:** The scoreboards should be at least 25' wide and 7' tall. The preference is 28' wide and 8' tall.
6. **Question:** If a 25' model is required for bid, we do not manufacture this size, however we can provide a 24' wide scoreboard, would that be sufficient? Our 24' model 1606 is exactly like Daktronics model listed on the solicitation, # BA-2125.
Answer: See Question 5
7. **Question:** Also, there is no mention of controls or any other accessories required to operate the boards. Where should I include the pricing for these? (controls and wireless receivers)
Are photos of the existing scoreboard structures available to bidders by email? Wireless controls and receivers

Answer: The price for all accessories (controllers and receivers) required to operate the boards should be included in the price of the board. Please note what accessories are included with your bid. Pictures of the existing scoreboards at Dutch Fork High School are included in this addendum. Site visits are recommended at each school.

8. **Question:** The Fair-Play and Nevco scoreboard models listed in the specification are both 28'L x 8'H. The Daktronics board specified is 25'L x 7'H.

Would it be appropriate to bid a Fair-Play board that is 26'L x 6'6"H that has all the same features as the larger board? The size of the scoreboard cabinet does affect the price.

Answer: See question 5.

9. **Question:** There are no dimensions given for the identification panel. We are assuming they would want the panel length to match the scoreboard length. If that is not the case, please advise length of panel. More importantly, please provide a height for the panel. Typical heights for this size board are 2'H and 3'H. Other heights are available. Please advise as this affects price.

Answer: The panel length should match the scoreboard length. The height should be 3'.

10. **Question:** Will any of the sign panels be used to display sponsor ads? If so, do you know how many ads would be placed on each panel?

Answer: The panels will not be used to display sponsor ads.

11. **Question:** Are the protective nets to be sized to protect the sign panels with the scoreboards, or do just the scoreboards need to be protected?

Answer: The nets are for the scoreboards only.

12. **Question:** Are the new scoreboards to be wired or wireless?

Answer: The new scoreboards are to be wireless.

13. **Question:** Do you want the pricing to include Electronic Team Names for any of the scoreboards?

Answer: Yes.

14. **Question:** I did not see a pre-bid meeting date or site visit instructions in the bid document. Are site visits allowed? If so who is the contact for site visits?

If further questions arise during or after a site visit, can the question deadline be extended?

A site visit would be necessary to determine if existing structures are appropriately sized and spaced to accommodate the new scoreboards, and to determine the condition of those structures.

Answer: Site visits are strongly recommended. Any questions that arise after the site visit will be answered by another addendum as long as they are received before the day of the bid opening. The bid opening has been extended to March 8, 2018.
