Responses Dated: July 29, 2021

Question 1. **There is no usage listed on this bid. Can you please provide annual usage per item?**

Answer. The Department does not track annual usage but rather replacement of items per employee request and need within their annual allotment.

Question 2. **The bid requests that all items include embroidery, Screen printing and attachment of patches. Can you please provide what customization is required per item? This is necessary in order to quote accurately.**

Answer. **Patches:** Class B short sleeve and long sleeve 2 patches 1 each sleeve. Badge shirt short sleeve and long sleeve 2 patches 1 each sleeve. Tactical jacket 2 patches 1 each sleeve. 911 fleece zip up jet black hoodie 2 patches 1 each sleeve. **Embroidery:** KFD scramble 2 colors on all Polo shirts including command staff. 5.11 job shirt KFD scramble 2 colors. 911 fleece zip up hoodie embroidered name first initial last name white. Richardson Flex Fit Baseball Hat KFD scramble 2 colors. Beanie KFD scramble 2 colors Boonie hat Kingman fire Department 2 colors. Tactical Jackets KFD scramble 2 colors. **Screen Printing:** on all 5.11 duty shirts short sleeve and long sleeve front of shirts Maltese and rank all white, back of shirt KINGMAN FIRE DEPARTMENT 2colors. 911 fleece zip up jet black hoodie back only 911 KINGMAN DISPATCH CENTER all white. PT shirt Next Level Grey back only KINGMAN FIRE DEPARTMENT all white, PT Hoodie independent Trading back only KINGMAN FIRE DEPARTMENT all white.
