GEORGETOWN COUNTY EMULSIFIED ASPHALT PAVEMENT SEALING PRESERVATION PROJECTS UTILIZING C-FUNDS

Purpose:

Georgetown County utilizes C-Funds awarded for emulsified asphalt pavement sealing projects that originate with the SC Department of Transportation (SCDOT) that may also involve flow-down Federal funds. For compliance with C-Fund award procedures, this solicitation will use the SC Consolidated Procurement Code provisions resulting in issuing a purchase order for the projects described within this bid. Due to the nature of funding for this agreement, local vendor preference will be waived for this solicitation. The award will be for the lowest qualified bidder as a complete total of all 5 project bids.

SPECIAL CONDITIONS:

- 1. Of total state source highway funds, including revenues generated by state code Section 12-28-2740, not less than:
 - a) 5% are expended through direct contracts with estimated values of \$250,000 or less with small business concerns owned and controlled by socially and economically disadvantage ethnic minorities (MBEs);
 - b) 5% are expended through direct contracts with estimated values of \$250,000 or less with firms owned and controlled by disadvantaged females (WBEs);
 - c) The \$250,000 limits may be raised in the discretion of the County as MBEs/WBEs are able to provide bond ability.

2. During the performance of this Contract, the Contractor agrees to provide equal employment opportunities. The Contractor will not discriminate against any employee or applicant for employment because of race, creed, color, sex, age, national origin, physical handicap, or marital status.

3. By submitting an offer, Offeror certifies that it will comply with the applicable requirements of Title 8, Chapter 14 of the South Carolina code of Laws (originally enacted as Section 3 of The South Carolina Illegal Immigration act, 2008 S.C. Act No. 280) and agrees to provide upon request any documentation required to establish either: (a) the applicability of Title 8, Chapter 14 to Offeror and any subcontractor or sub-subcontractors; or (b) the compliance with Title 8, Chapter 14 by Offeror and any subcontractors or sub-subcontractors. Pursuant to Section 8-1460, "A person who knowingly makes or files any false, fictitious, or fraudulent document, statement, or report pursuant to this chapter is guilty of a felony and, upon conviction, must be fined within the discretion of the court or imprisoned for not more than five years, or both". Offeror agrees to include in any contracts with its subcontractors language requiring the subcontractors to (a) comply with the applicable requirements of Title 8, Chapter 14, and (b) include in any contracts with the sub-subcontractors language requiring the sub-subcontract to comply with the applicable requirements of Title 8, Chapter 14.

TECHNICAL SPECIFICATIONS

SCOPE OF WORK

Georgetown County (County) seeks to implement a pavement preservation projects. The County intends to retain a vendor that specializes in the application of High Performance Mineral and Fiber Reinforced Asphalt based Emulsion (hereinafter "sealer") for low, medium, and higher volume County roads.

These specifications request rates for furnishing of all materials, equipment, and labor rates for performing all work and operations in connection with the application of sealer and all other incidental and related work as set forth in these specifications and as directed by Georgetown County.

APPLICABLE STANDARDS

The County is not limiting consideration for this solicitation to a particular brand. There are many thick aggregate blended, durable, High Performance Mineral and Fiber Reinforced Asphalt Emulsion Sealers available on the market. Examples of commercially available products are include but are not limited to; GuardTop's "<u>GuardTop Ultra</u>" and Sealmaster's "<u>Liquid Road Ultra</u>."(***ultra or equivalent, not the standard version of these products***). The use of a "brand name or equal" specification is for the purpose of describing a standard of quality, performance, and characteristics that would be considered. This is not intended to limit or restrict competition.

Georgetown County is <u>only</u> interested in the application of asphalt based sealers. Sealers that are coaltar based shall not be considered for this solicitation.

ROAD SURFACE PREPARATION

The chosen vendor shall perform all required work ensuring that the following considerations be met.

The sealer must be applied to sound asphalt surfaces. Sealing is not a means of resurfacing but rather is formulated to protect against UV related aging, drying, damage from oil and gasoline leakage, and to prevent water penetration.

Contractor Responsibilities

Prior to sealer application, the surface shall be cleaned and swept of all foreign material and dust. The shoulders shall be clipped and cleaned of dirt and debris. Dispersion of dust and debris into the air and surrounding environment shall not be allowed. Further, older paved surfaces shall also be cleaned and free of residual oils, chemicals, or fuel spills to the maximum extent practicable.

Newly paved surfaces should cure a minimum of four (4) weeks under ideal weather conditions (70°F) prior to application of sealer.

Inspection

- Examine pavement surface prior to performing work
- Notify County of any adverse or unacceptable conditions that would affect successful repair efforts or application of materials
- Do not commence work until unacceptable conditions are corrected

Resident Notification

- It will be the responsibility of the Contractor to notify residents one week in advance of scheduled work.
- The contractor shall distribute paper notifications to each resident

Crack Repair

- Cracks must be free from dust, dirt, vegetation and moisture
- For all cracks up to 1" wide apply ASTM compliant hot rubberized crack sealant
- Contractor shall refer to crack sealant manufacturer's product data sheet for more detailed application instructions

Fatigue Cracked Pavement Repair

Fatigue cracking, often referred to as alligator cracking, is a series of interconnected cracks which resemble an alligators skin. Fatigue cracking is caused by load based asphalt deterioration resulting from a weakened base course or subgrade, overloading, minimal asphalt thickness, or any combination of the above. Prior to sealing, the contractor shall repair deteriorated asphalt sections.

Hot Mix Asphalt

Usage of HMA pavement for minor repairs prior to sealing may consist of one or more courses of HMA base, intermediate, or surface mixtures produced and placed in accordance with the specifications herein and shall be in conformance with Section 400 of South Carolina Department of Transportation (SCDOT) Standard Specifications. The mixture type shall be "Type C", must meet the requirements specified:

A copy of the SCDOT Certified Plant Certificate for the plant(s) producing HMA mixtures for this project **must be** submitted upon award of contract.

Pothole Repair

Prior to application of sealer, any existing potholes shall be repaired. Potholes will be sawcut as to make square edges. The repair will have an Asphalt Binding Agent (SS-1H) applied. HMA shall be used to repair potholes prior to sealing.

SEALER APPLICATION METHODS

Traffic Control

All operations shall be coordinated to result in the least practical delay of traffic. One way traffic or an appropriate and safe means of ingress/egress shall be maintained at all times. The Contractor shall provide traffic control as necessary to conform to the latest revision of the Manual of Uniform Traffic Control Devices (MUTCD). The work shall be coordinated so that traffic will be permitted upon the sealed surface within a safe timeframe as drying permits.

Utility Protection

Utility covers, manholes, grated inlets, curb inlets, and traffic device covers located in the roadway shall be protected from coverage and referenced for prompt location and cleaning following application. The Contractor shall be responsible for covering, locating, removing and cleaning following application. The methods used to protect, reference, locate and clean shall be submitted by the Contractor and shall be subject to approval by the Project Manager. All such materials shall be removed and properly disposed of by the Contractor at the end of each workday.

Surface Protection

- Use tar paper to mask off end of streets and intersections to provide crisp start and finish lines when applying sealer
- Use tar paper or suitable material to mask off manhole covers and sewer grates
- Protect curbs, gutters and sidewalks from material spatter or over-coating.
- All asphalt transitions (i.e. curb, storm structures) edges shall be dressed out and all grass, weeds, or other invasive vegetative growth shall be removed and disposed up prior to sealing

Environmental

The Contractor will, at their expense, obtain any applicable permits required to complete the work while adhering to all current environmental standard practices and regulations regarding all sealer, HMA, or paint application, material removal, products, cleaning, and disposal of project waste.

Sealer Mixing Procedure

Sealer aggregate shall be mixed in accordance with manufacturer's specification.

Application Procedure

Sealer shall be applied per the manufacturer's recommendations to a minimally acceptable coverage rate as specified below. Two coats of sealer is required. The coverage rate shall follow:

Surface Condition	Coverage Rate/ Per Coat
Smooth	≈4.4 SY/Gal
Medium	≈3.7 SY/Gal
Rough	≈3.0 SY/Gal

Pavement Lane Markings

Pavement markings shall not be used where there are no existing painted lane markings unless directed by the County. However, for roads where existing markings would be covered and new markings reapplied, the following specifications adhere:

Traffic paint pavement markings that comply with Section 625 of SCDOT 2007 Standard Specifications for Road and Bridge Construction may be used. Permanent application of painted markings shall be applied to clean, 'cured' surface.

Application methods and equipment shall comply with SCDOT Standard Specifications for Highway Construction. Only stop bars are specified as thermoplastic application.

Ambient Conditions

Sealer shall be applied only during the contract period specified. Ambient air temperatures must be a minimum 50°F and rising. Ambient and surface temperature shall not drop below 50°F for a 24 hour period following application of materials. Pavement temperature must be a minimum of 70°F. Weather forecast should not call for rain within or shortly after the anticipated work time frame.

1. Submission of Questions

Questions must be submitted in writing via electronic mail, facsimile or postal mail to the Issuing Officer no later that the "Deadline for Questions" cutoff identified in the Bid Timeline on page four (4) in order to generate an official answer. All written questions will receive an official written response from the Georgetown County Purchasing Office (GCPO) and will become addenda to the solicitation.

GCPO reserves the right to reject or deny any requests made by the provider.

Impromptu, unwritten questions are permitted and verbal answers may be provided, but are only intended as general direction and will not represent the official GCPO position. The only official position of GCPO is that which is stated in writing and issued in the solicitation as addenda thereto.

No other means of communication, whether oral or written, shall be construed as a formal or official response/statement and may not be relied upon. SEND QUESTIONS TO:

- Sealed bids to provide <u>Emulsified Asphalt Pavement Projects</u> shall be received electronically through the County's Vendor Registry webpage until the cut-off time shown in the bid timeline on page three (3) of this document. Bids will then be promptly opened at the designated time by the Buyer. Bids that are not received prior to the stated opening date and time will be considered <u>NON RESPONSIVE</u>. An official authorized to bind the offer must sign all bids submitted.
- 3. <u>Inclement Weather/Closure of County Courthouse</u> Due to the current COVID-19 situation, County offices at the time of this bid posting remain open but are closed to the public. However, bid openings may occur from an alternate secure and/or remote location as needed.
- 4. NON EXCLUSIVITY

Nothing herein is intended nor shall be construed as creating any exclusive arrangement with Contractor. Any resulting contract shall not restrict the County from acquiring similar, equal or like goods and/or services from other entities or sources, when Staff determines internally that this resulting action is in the best interest of Georgetown County.

- 5. <u>No Bidder may submit more than one bid</u>. Multiple bids for different manufacturers but represented by the same firm will not be accepted. Bids offered directly from manufacturers shall indicate if a local dealer/representative will be involved.
- 6. Bidders shall be licensed as a General Contractor in the State of South Carolina and will hold all Trade Contracts and the Building Permit on the Project.

7. Trade Contractors (Prime and sub-contractors) shall be qualified to perform the work contracted for ^{9 of 29} and shall be licensed as such in the State of South Carolina.

- 8. Any additional design services shall be performed by qualified architects and engineers licensed to perform the contracted work in the State of South Carolina.
- 9. Definitions:
 - a) The terms "Proposer", "Offeror", or "Bidder" refer to those parties who are submitting sealed responses for the work set forth in this document to the OWNER, as distinct from a sub-bidder who provides a bid to the Bidder. The term "Contractor" refers to the successful Bidder.
 - b) The term "Emulsified Asphalt Pavement Sealing Projects," or "Project" refers to the **complete set of services and materials** as specified in this document, in every aspect.
 - c) The terms "Owner" and "County" refer to the County of Georgetown, South Carolina.
 - d) Where the words "shall" or "must" are used, it signifies an absolute minimum function or capacity that, if not satisfied, may result in disqualification.
 - e) Where the words "should", "may", or "is desirable" are used, it signifies desirable, but not mandatory functions or capacities. Bidders who are able to provide these functions or capacities may be evaluated more favorably that those who cannot.
- 10. Correction or Withdrawal of Bids; Cancellation of Awards

An offeror must submit in writing a request to either correct or withdraw a bid to the Procurement Officer. Each written request must document the fact that the offeror's mistake is clearly an error that will cause him substantial loss.

- a) Correction of awards : An offeror shall not be permitted to correct a bid mistake after bid opening that would cause such offeror to have the low bid unless the mistake in the judgment of the Procurement Officer is clearly evident from examining the bid document; for example, extension of unit prices or errors in addition.
- b) Cancellation of awards prior to performance: When it is determined after an award has been issued but before performance has begun that Georgetown County's requirements for the goods or services have changed or have not been met, the award or contract may be canceled and either re-awarded or a new solicitation issued.

11. Faxed or E-mailed bids will not be accepted by Georgetown County. Electronic bid submissions must be submitted through the Georgetown County Purchasing Vendor Registry page to ensure they remain sealed until the scheduled bid opening date and time.

- 12. If you need any reasonable accommodation for any type of disability in order to participate in this procurement, please contact the purchasing office as soon as possible.
- 13. Title VI of the Civil Rights Act of 1964: Georgetown County hereby gives public notice that it is the policy of the agency to assure full compliance with Title VI of the Civil Rights Act of 1964, the Civil Rights Restoration Act of 1987, Executive Order 12898 on Environmental Justice, and related statutes and regulations in all programs and activities. Title VI requires that no person in the United States of America shall, on the grounds of race, color, or national origin, be excluded from the participation in, be denied the benefits of, or be otherwise subjected to discrimination under any program or activity for which Georgetown County receives federal financial assistance. Any person who believes they have been aggrieved by an unlawful discriminatory practice under Title VI has a right to file a formal complaint with Georgetown County. Any such complaint must be in writing and filed with Georgetown County's Title VI Coordinator within one hundred and eighty (180) days following the Bid # 20-035

- 14. Any deviations from the specifications or modification of this bid and any extra or incidental work or reductions in work shall be set forth in writing and signed by both parties prior to making such change. Any increase or decrease in the bid price resulting from such change shall be included in writing.
- 15. Exceptions: The bidder shall list on a separate sheet of paper any variations from, or exceptions to, the conditions and specifications of this bid. This sheet shall be labeled "Exception(s) to Bid Conditions and Specifications," and shall be attached to the bid. When Proposers find instances where they must take exception with certain requirements or specifications of the bid, all exceptions shall be clearly identified. Written explanations shall include the scope of the exceptions, the ramifications of the exceptions for the County of Georgetown, and a description of the advantage to be gained or disadvantages to be incurred by the County as a result of these exceptions.
- 16. The County reserves the right to reject any or all bids, waive any informality in bids and accept in whole or in part such bid or bids as may be deemed in the best interest of the County. Georgetown County reserves the right to reject any bid submitted, at sole option that the vendor may not be able to meet the service requirements of the bid.
- 17. Publicity releases: contractor agrees not to refer to award of any resulting contract in commercial advertising in such a manner as to state or imply that the products or services provided are endorsed or preferred by the user.
- 18. Material Safety Data Sheets: The County of Georgetown will not receive any materials, products, or chemicals which may be hazardous to an employee's health unless accompanied by a Material Data Sheet when received.
- 19. Ownership of Copyright: All right, title and interest in all copyrightable materials which vendor shall create in the performance of its obligations hereunder shall be the property of the procurer. Vendor agrees to assign and hereby does assign any and all interest it has in and to such material to procurer. Vendor agrees, upon the request of procurer to execute all papers and perform all other such acts necessary to assist procurer to obtain and register copyrights on such materials. Where applicable, works of authorship created by the vendor in the performance of its obligations hereunder, shall be considered "works for hire" as defined in the U.S. Copyright Act.
- 20. Ownership of Documents: Any reports, studies, photographs, negatives or other documents prepared by vendor in the performance of its obligations shall be the exclusive property of the procurer and all such material shall be remitted to the procurer by the vendor upon completion, termination or cancellation of this order. Vendor shall not use, willingly allow or cause to have such material used for any purpose other than performance of its obligations under this order without the prior written consent of the procurer.
- 21. Affirmative Action: The contractor will take affirmative action in complying with all Federal and State requirements concerning fair employment and employment of the handicapped, and concerning the treatment of all employees, without regard or discrimination by reason of age, race, color, religion, sex, national origin or physical handicap. The following are incorporated herein by reference: 41 C.F.R. 60-
- 22. All Federally Funded or Assisted Construction Contracts Over \$2,000:
- A. Davis-Bacon Requirements. These contracts need to include a provision for compliance with the Davis-Bacon Act (40 USC 276a to a-7) and the Department of Labor implementing regulations (29 CFR Part 5). Under this Act, Contractors are required to include the contract provisions in Section 5.5 (a) of 29 CFR Part 5, and to pay wages to laborers and mechanics at a rate not less than the minimum wages specified in the wage determination made by the Bid # 20-035 Secretary of Labor. In addition Contractors shall be required to pay wages not less than the Page 10 of 29

minimum wages specified in the wage determination made by the Secretary of Labor. In addition, Contractors shall be required to pay wages not less often than once a week. - B. Contract Work Hours and Safety Standard Act Requirements. The contracts must include a provision for compliance with Sections 103 and 107 of the Contract Work Hours and Safety Standards Act (40 USC 327-330) as supplemented by the Department of Labor regulations (29 CFR Part 5). Under Section 103 of the Act, each Contractor shall be required to compute the wages of every mechanic and laborer on the basis of a standard workweek of 40 hours. Work in excess of the standard workweek is permissible provided that the worker is compensated at a rate not less than one times the basic rate of pay for all hours worked in excess of 40 hours in the workweek. Section 107 of the Act is applicable to construction work and provides that no laborer of mechanic shall be required to work in surroundings or under working conditions which are unsanitary, hazardous, or dangerous to health and safety as determined under construction, safety and health standards promulgated by the Secretary of Labor. These requirements do not apply to the purchases of supplies, materials, or articles ordinarily available on the open market, or contracts for transportation or transmission of intelligence.
- C. Copeland "Anti-Kickback" Act Requirements. All construction contracts over \$2,000.00 must include a provision for compliance with the Copeland "Anti-Kickback" Act (18 U.S.C. 874) as supplemented in Department of Labor regulations (29 CFR Part 3). This act provides that each Contractor shall be prohibited from inducing, by any means, persons employed in the construction, completion, or repaid of public work to give up any part of their compensation.
- 23. Bidders must clearly mark as "confidential" each part of their bid which they consider to be proprietary information that could be exempt from disclosure under section 30-4-40, Code of Laws of South Carolina 1976, as amended (Freedom of Information Act). If any part is designated as confidential, there must be attached to that part an explanation of how this information fits within one or more categories listed in section 30-4-40. The County reserves the right to determine whether this information should be exempt from disclosure and no legal action may be brought against the County or its agents for its determination in this regard.

24. CERTIFICATION REGARDING DRUG-FREE WORKPLACE:

The contractor certifies that the vendor(s) will provide a "drug-free workplace" as that term is defined in Section 44-107-30 of the Code of Laws of South Carolina, 1976, as amended, by the complying with the requirements set forth in title 44, Chapter 107.

25. Certification of Non-Segregated Facilities

The federally-assisted construction contractor certifies that he does not maintain or provide, for his employees, any segregated facilities at any of his establishments and that he does not permit his employees to perform their services at any location, under his control, where segregated facilities are maintained. The federally-assisted construction contractor certifies that he will not maintain or provide, for his employees, segregated facilities at any of his establishments and that he will not permit his employees to perform their services at any location under his control where segregated facilities are maintained. The federally-assisted construction contractor agrees that a breach of this certification is a violation of the Equal Opportunity Clause in this Contract.

As used in this certification, the term "segregated facilities" means any waiting rooms, work areas, restrooms, and washrooms, restaurants and other eating areas, time clocks, locker rooms and other storage or dressing areas, parking lots, drinking fountains, recreation or entertainment areas, transportation, and housing facilities provided for employees which are segregated on the basis of

33. <u>Bids must be made on Proposal or Bid Form furnished or will be rejected.</u> Proposals shall be typewritten or written in ink on the form prepared by the County. The person signing the bid shall initial all corrections or erasures.

34. Insurance

The successful bidder shall procure, maintain, and provide proof of, insurance coverage for injuries to persons and/or property damage as may arise from or in conjunction with, the work performed on behalf of the County by the bidder, his agents, representatives, employees or subcontractors. Individual contractors shall provide their social security numbers, and proprietorships, partnerships, and corporations shall provide their federal employer identification number on the pricing form.

40. Progress Payments (If Applicable)

Contractor's Application for Payment shall be submitted to the Owner on AIA Document G702 and G703--1992 Edition, or such other form as may be mutually agreed upon. The period covered by each Application for Payment shall be not less than one calendar month. The Owner shall make progress payments to the Contractor on undisputed amounts certified by the Architect within twenty-one (21) days from receipt of the Application for Payment by the Owner in accordance with Title 29, Chapter 6 of the Code of Laws of South Carolina, 1976, as amended.

41. South Carolina Sales Tax

The County of Georgetown, SC is <u>not</u> exempt and pays the appropriate SC sales tax on all applicable purchases.

42. Assignment of Contract

This contract may not be assigned in whole or part without the written consent of the Purchasing Officer.

43. Termination

Subject to the provisions below, the contract may be terminated by the County upon thirty (30) days advance written notice to the other party; but if any work or service hereunder is in progress, but not completed as of the date of termination, then this contract may be extended upon written approval of the County until said work or services are completed and accepted.

a. <u>Termination for Convenience</u>

In the event that this contract is terminated or canceled upon request and for the convenience of the County, without the required thirty (30) days advance written notice, then the County shall negotiate reasonable termination costs, if applicable.

b. <u>Termination for Cause</u>

Termination by the County for cause, default or negligence on the part of the contractor shall be excluded from the foregoing provision; termination costs, if any, shall not apply. The thirty (30) days advance notice requirement is waived in the event of Termination for Cause.

c. <u>Non-Appropriation:</u>

By executing this Agreement, all parties specifically consent to venue and jurisdiction in Georgetown County, South Carolina and waive any right to contest jurisdiction and venue in said Court.

48. Rights of County

The County reserves the right to reject all or any part of any bid, waive informalities and award the contract to the lowest responsive and responsible bidder to best serve the interest of the County.

49. Award of Bid

In determining the lowest responsive and responsible bidder, in addition to price, there shall be considered the following:


