1. Can you please provide the bid tabulation for year 2019?

Answer:

The bid tabulation for 2019 is attached found on pages 3 and 4 of this addendum.

- 2. Regarding the Purate Technology specifications for the equipment:
 - a. How many Chlorine Dioxide generators are currently in place?

Answer:

We have one at each water treatment plant. Three (3) total.

b. What is the required output from each of them at their current locations?

Answer:

Hooper Plant......133 lbs./day

Hicks Plant......30 lbs./day

Smith Plant54 lbs./day

c. Any other details or specifications regarding this equipment?

Answer:

No further details or specifications regarding this equipment outside of what was given in the Request for Bid documents.

3. Could you amend the bid specifications to call for Purate® "or Equal"?

Answer:

No, without testing of alternate chemical there is too much unknown. You may get with the plants over the next year and complete testing. If the testing comes back good, we can then look at adding this option.

4. Will you amend the bid specifications to state that only suppliers carrying the required certifications for use in drinking water be eligible?

Answer:

No, all chemicals must be certified for use in drinking water.

5. a. Does CCWA own the Purate® CIO2 generator equipment?

Answer:

Yes, CCWA owns the three (3) CIO2 generators.

b. Does Nalco include the generator equipment along with chemistry and service in their offer?

Answer:

Nalco does not include the generator equipment in the offer. They do include the service in their offer.

6. a. Is it your intention to continue or begin using the Purate® generator equipment?

Answer:

Continue to use. We currently use three (3) generators.

b. Or would the vendor need to supply new equipment.

Answer:

No, we already have all the equipment.

7. What has been the historical usage of powdered activated carbon for the past couple of years?

Answer:

Over the past few years, we have increased the carbon feed. Currently we average about 900 lbs./Day overall with all sites included.

8. What is the typical order quantity of powdered activated carbon?

Answer:

Super sacks- Roughly 300,000 lbs. a year.

50 lb. bags- Roughly 36,500 lbs. a year.
