SUBJECT: Addendum 1 to Invitation for Bid 40622 – Burrell Dam Manatee Screens Fabrication and Installation

As a result of questions received from potential respondents during the non-mandatory pre-bid meeting, please be advised of the following changes to the subject Invitation for Bid:

- 1. The time and date for the submittal of responses remains the same: <u>2:00 p.m., Thursday, November 21,</u> <u>2024</u>
- 2. Question: Is herbicide required for this project?

No, herbicide is not required for this project, omit paragraph 8. MINIMUM QUALIFICATIONS AND OTHER REQUIRED DOCUMENTATION, section c.

3. **Question:** If the screens are only 10 feet tall and the water is much deeper. What keeps the manatees from going over the screens?

The water level would need to be excessively high for this to occur.

4. **Question:** Where are the bulkheads located? Will the District be transporting the bulkheads to the project site or will that be a requirement for the contractor?

This project will not involve dewatering or use of the bulkheads.

5. **Question:** Can you do the work from the water side with a crane?

Yes, work can be down on the water side and there should not be an issue. The piling cannot be removed but the buoy can be unhooked and removed for access.

- 6. **Question:** Will the District be responsible to closing the gates during installation? Yes, the District will be responsible for closing the gates for installation.
- 7. **Question:** Will the project take place during manatee migration season? Manatees do not utilize this structure for migration.

- 8. **Question:** Will the District be responsible for closing the gates during installation? During the duration of the project the District can close the gates.
- 9. **Question:** Was the last inspection during the rehab10 plus years ago were there any measurements taken?

The District took measurements using a tape measure from the surface through the grates of the structure but did not get into the water to inspect for changes below the water surface.

10. Question: Will this project be considered a Publics Works Project in terms of the steel code?

Yes, attached is the revised Cost Schedule with AIS Requirement language. This is also in the SAMPLE AGREEMENT, section 32. IRON AND STEEL FOR PUBLIC WORKS.

11. Question: Do you have the existing screens or a template?

This project will create the first screens ever existed at this site.

12. **Question:** Do you know the water depth at the opening of the gates?

The water depth can be up to 3.3 ft at the front gates and up to 7.3 ft at the side gates.

- 13. Question: Can a boom truck gain access to the project site through the side gate?Yes, equipment can come through the side gate just be mindful of overhead power lines.
- 14. **Question:** The Statement of Work calls for galvanized can aluminum be used? No, aluminum cannot be used on this project.
- 15. **Question:** Spalling is notices on some of the post, is there any spalling below the water surface? Will a dive be required?

The condition below the water line is not known. Any spalling of the concrete will be addressed at a future date and is not part of this project. Yes, a dive will be needed to ensure the screens are seated properly

16. Question: Do you want certified commercial divers or someone with scuba experience?

All dive operations shall meet the requirements and qualifications of OSHA 29 CFR 1910 Subpart T Commercial Dive Operations.

17. **Question:** Will an alligator trapper request be submitted through the District? If we need one request it from the PM or include it in the pricing?

It is the contractor's responsibility to procure alligator trapping services, if required.

18. Question: What is the completion date?

The Completion Date is March 31, 2025 as state in the ATTACHMENT A – STATEMENT OF WORK, section V. TIME FRAMES AND DELIVERABLES.
