November 18, 2015 REQUEST FOR PROPOSAL: Fuel Supply - Diesel and Unleaded Gasoline

The Whitfield County Board of Education (WCBoE) invites proposals for a **Fuel Supply – Diesel and Unleaded Gasoline** to enter into contract for the purchase of diesel fuel and unleaded gasoline during the calendar year of <u>January 1, 2016</u> through December 31, 2016. In accordance with O.C.G.A. 20-2-506 this contract may be automatically renewed for up to 4 successive calendar years at the discretion of WCBoE. Renewals are contingent on written notification from WCBoE to vendor within 30 days of the end of each of the 4 terms. Vendor may end the annual renewals with 120 days written notice sent to Whitfield County School System, Director of Transportation

PARTICIPANTS ARE INSTRUCTED TO CAREFULLY READ ALL ITEMS, TERMS, CONDITIONS AND SPECIFICATIONS.

Participants are required to provide ALL information requested in this RFP. Failure to include the requested information or items may result in rejection of proposal. WCBoE reserves the right to utilize the information submitted to do what is in the best interest of the school system.

Hard copy proposals should be mailed or hand delivered to Whitfield County School System Operations Complex, Attention: Transportation Department, 1030 Hill Road, Dalton, GA 30721.

<u>Proposals must be received by 1:00pm on December 2, 2015</u>. Respondents are cautioned to mail quotes in ample time for delivery prior to the due date. **PROPOSALS RECEIVED LATE WILL BE REJECTED.**

- 2.3 Proposals must arrive no later than 1:00 p.m. (EST) on Tuesday December 2, 2015. Proposed systems / services will be evaluated by a team representing the Transportation Department of Whitfield County Schools and a decision will be reached by consensus of all parties involved as to the suitability and appropriateness of the system / services. All companies who submit a proposal will be notified of the final award.
- 2.4 This proposal is based on available funding; therefore, the contract cannot begin until Whitfield County Schools has issued a PO.
- 2.5 Full cost of preparation is to be borne by the quoting company.
- 2.6 Proposals must be signed in ink by a company official with authorization to commit company resources.
- 2.7 The Whitfield County Board of Education reserves the right to reject all proposals, or to select one that the Board considers the most advantageous for the Board.
- 2.8 The Board shall pay the firm for services when these services have been completed and signed off by the Director of Logistics.
- 2.9 The site and any equipment located thereon should be thoroughly examined in relation to conditions that might directly or indirectly affect the delivery, storage and dispensing of fuel at the fueling sites listed below in this proposal. The proposal sum shall reflect all such affecting conditions. Vendors shall be responsible for verifying all dimensions that may affect the work.
- 2.10 All prices proposed are to be FOB delivered to Whitfield County Schools at the sites listed in Section 7.0. The vendor must assume all responsibility for damage in transit.

SECTION 5.0 PROPOSAL REQUIREMENTS

Proposal Requirements:

The proposal must include the following items in a systematic organization in order specified to be considered a complete proposal:

- A. Section 3.0 Proposal form.
- B. A brief statement of the general background and capabilities of the firm submitting the proposal.
- C. One reference: including phone numbers, addresses, and contact person. This reference should be someone who has received and used the same product/s or services.
- D. An expression of agreement to meet or exceed specifications outlined in this RFP.
- E. Price proposal should include initial year cost to include any hardware/software/services required to provide a functional system / meet proposal requirements and the cost of subsequent year's support and maintenance agreements.
- F. The total costs should be broken down to include an itemized list including unit costs of products requested in this RFP. The total cost should include shipping, delivery, installation, training and any other costs of products and materials associated with providing a functional system.
- G. Provide a copy of any product guarantees and warranty information.

SECTION 6.0 SYSTEM / SERVICE REQUIREMENTS

Service Requirements:

Vendor proposals must, at a minimum, include the following services in the order specified:

- 1. Guarantee of consistent fuel pricing with rates and pricing formula defined in contract. Preference of pricing formula is "Low Rack Price" + Price per Gallon.
- 2. Contract will be valid for a period of one calendar year and may, at the discretion of both parties and in accordance with O.C.G.A. 20-2-205, be extended for 4 additional calendar year terms without further bidding.
- **3**. Contract will guarantee fuel availability to Whitfield County Board of Education fuel sites as long as the vendor has access to any fuel supply. This guarantee will also apply during times of disaster and national shortage.
- 4. Fuel storage tank monitoring, maintenance, training, as well as State required reporting, environmental compliance, and certification is to be managed by vendor and must be defined in the contract.
- 5. Vendor agrees to provide labor for maintenance and repairs to WCBoE owned fuel tanks and fuel dispensing equipment. WCBoE will be responsible for cost of parts to provide maintenance and repair.
- 6. Vendor agrees to provide WCBoE with an emergency / backup fueling sight in Whitfield County.

SECTION 7.0 FUELING SITE DETAILS

Whitfield County Board of Education operates a fleet of diesel fueled school buses and a smaller "white" fleet of gasoline fueled service vehicles. Annual total fuel consumption for all three sites is estimated to be: Diesel = 242,065 gallons and Unleaded Gasoline = 28,269 gallons. Vehicles are fueled at WCBoE owned sites at the following locations. All fuel sites have electronic fuel management systems and network / internet connectivity.
