Specifications for a Tandem Axle Enclosed V Nosed Cargo Trailer – Bumper Pulled

The trailer shall be 20' long, 8' foot wide and 8' 6" high with a deck height of 14". The rear door opening shall be a minimum of 7' 6"

G.V.W.R shall be 10,400 #.

The two axles shall be Tandem Dexter 5200#.

Suspension shall be Eye-to-Eye Springs with Equalizer.

Electric brakes shall be on all axles.

The wheels shall be painted 16", 6-bolt with 16" Radial tires. Hub caps shall be installed on all wheels.

The frame shall be 2" x 3" angle iron with 2" x 2" angle iron crossmembers on 16" centers

The tongue shall be constructed of 3" channel iron with 3/8" heavy duty safety chains and safety latch hooks. A top wind 7000# jack with wheel shall be attached to the channel iron..

A full size side door witk recessed handle and lock shall be installed.
