Sealed Bids for the construction of the **Wesleyan Drive and Cypress Drive Drainage Improvements** will be received by the **City of Laurinburg, Attn: Harold W. Haywood, 303 West Church Street (Room 242), Laurinburg, NC, 28352, until 2:00 PM** local time on **Monday, April 5<sup>th</sup>, 2021**, at which time and place the bids will be publicly opened and read aloud.

**Because of restrictions for group gatherings in response to COVID-19, the City of Laurinburg offices will be closed to the public at the scheduled bid opening time. Bids shall be mailed in accordance with the Instructions to Bidders contained in the Project Manual or dropped off at the City Hall drive up window located at 303 W. Church Street. The Bid Opening will be livestreamed on the City's Facebook page, City of Laurinburg Government, with a link to this page on its website, [www.laurinburg.org](http://www.laurinburg.org). Look for the link at the top of the website page that says "Public Bid Opening (Live Stream)".**

The Project consists of constructing the following:

- Site 1 - Drainage Improvements located near Wesleyan Drive to include, but not limited to, clearing, grading, drainage repairs and culvert replacements
- Site 2 - Drainage Improvements located along Cypress Drive to include, but not limited to, grading, drainage repairs and culvert replacements

These Projects have expedited schedules tied to USDA Grant Funding. Notice to Proceed (NTP) for both projects is expected on April 7<sup>th</sup>, 2021, and Contract Duration will be 40 days, so that project completion will be by May 17<sup>th</sup>, 2021.

Bids will be received for a single prime Contract. Bids shall be on a lump sum and unit price basis, with additive alternate bid items as indicated in the Bid Form. **The Owner reserves the right to award the Project Sites separately or together and Bids will be evaluated per Site.** The City of Laurinburg is an Equal Opportunity Employer and invites the submission of proposals from minority and women-owned firms. The City reserves the right to reject any or all proposals.
