### Escambia County, Natural Resources Management Bid Closes February 10, 2021

The following is a request for proposals for planting at 4 County owned locations. The bid has potential to be awarded to separate contractors, each location should be itemized separately. Bid is to purchase, install and water-in according to ANSI 300 and ISA national standards requested tree species. Trees are to be rated and meet the most recent Florida No. 1 or better standard by the *Florida Department of Agriculture and Consumer Services, Florida Grades and Standards for Nursery Plants*. Rating standards *include* but not limited to no circling roots, tree height and caliper appropriate for container size. Trees shall be planted per the American National Standard practices for transplanting (ANSI A300 part 6). Including:

- Watering in trees to ensure proper soil settling around root ball with no air pockets using up to 20 gallons of water per tree. (Depending on container size and site conditions)
- Cutting and folding down top 2 tiers of B&B wire basket into the planting hole
- Removing all twine, rope, wire and burlap from the top half of root ball.
- Using weed free pine straw mulch.
- Staking only if necessary
- Minimizing site disturbance

Bid should show break down pricing per species and container size of the tree. Specify approved equal if appropriate. "Tree planting/ installation" will be warrantied for survival for 6 months. (County will be responsible for irrigation). Contractor may be requested to add Soil moist or like product to planting area depending on conditions Product and specifications will be supplied by the County.

Contractor should be a member of at least one professional organization. (International Arboriculture Society, Tree Care Industry Association or Florida Nurseryman's Association or similar). Contractor should be prepared to install trees within 2 weeks of bid acceptance. **Please return bids via website or below email prior to February 10, 2021.**

## Location 1 Olive Road East Stormwater Pond At Johnson Ave

Planting arrangement is 3 groups of 10 trees placed along interior fence line on Olive Road. Tree location will be flagged by County staff prior to planting.

- Ten Eastern Red Cedars, *Juniperus virginiana* 2.0" to 3.0" caliper. 9 foot or greater with a full canopy to ground.
- Twenty (20) Southern Magnolia, *Magnolia grandiflora* 'Brackens Brown Beauty 2.0" to 3.0" caliper. Trees are to be 9 foot or greater with a full canopy to ground.

Trees are to be placed approximately 15 feet from fence line in an arrangement marked by County Staff. Planting specifications are on page 1 of 6. Trees are to have a tree well outside of the root ball area as indicated in the Tree w/ berm diagram.

- Nine (9) Live oaks, *Quercus virginiana* 2.5" to 3.5" caliper
- Five (5) Red Maples, Acer rubrum 2.5" to 3.0" caliper
- Four (4)) Willow Oaks, *Quercus phellos* 2.5" to 3.5" caliper
- Four (4) Sycamores, *Platanus occidentalis* 2.5" caliper

Trees are to be placed in an arrangement marked by County Staff. Planting specifications are on page 1 of 6. Trees are to have a tree well outside of the root ball area as indicated in the Tree w/ berm diagram.

One (1) one Sycamore, Platanus occidentalis 2.5" to 3.5" caliper




Remove and replace one declining 3" caliper sycamore per planting specifications on page 1 of 6. Coordinate with County Staff on tree to be removed and replaced. Trees are to have a tree well outside of the root ball area as indicated in the Tree w/ berm diagram.
