If any work provided for or to be performed under any Specifications is sublet (as otherwise permitted by the terms of such Specifications), the Contractor shall require the sub-contractors to maintain and furnish him with satisfactory evidence of Worker's Compensation, Employer's Liability and such other forms and amounts of insurance which Contractor deems reasonably adequate.

SPECIFICATIONS

1.0 SCOPE AND CLASSIFICATION

- 1.1 **Scope:** The City of Canton and the Canton City Public Health, Air Pollution Control Division, is seeking bids for a service contract for exterior residence cleaning within the designated area south and east of Republic Steel. The services for this cleaning program will be in effect between April 1, 2024 through October 31, 2024. No cleanings shall be completed after October 31, 2024.
- 1.1.1 The services provided in this contract will be performed strictly on a first come, first served basis and are contingent on the availability of funds.
- 1.2 **Classification:** The successful bidder will provide thorough exterior residence cleaning services at the homes within the designated area per the specifications, terms and conditions included in this bid packet, proposal page and the resulting contract. Services shall include power washing, manual scrubbing, cleansers, etc.
- 1.3 This will be a voucher program that will be paid from the Republic Canton Community Fund, per the December 12, 2023 State vs. Republic Steel settlement as established with the City per Ordinance 11/2024 and Canton City Public Health per Resolution 2024-03.

2.0 APPLICABLE PUBLICATIONS & STANDARDS

- 2.1 All exterior residence cleaning, power washing and related functions shall meet or exceed all of the requirements and environmental regulations set by the Ohio Environmental Protection Agency for Mobile Power Washing Service.

3.0 REQUIREMENTS

3.1 General Requirements

- 3.1.1 **Price:** All bidders are requested to bid fixed, firm pricing for the duration of the contract(s) in the spaces provided on the proposal pages. Bids subject to an escalator clause will not be considered.
- 3.1.2 **Term**
- 3.1.2.1 Contracts resulting from this bid will be as needed service contracts. Most locations will require only one standard cleaning service. Some locations will be permitted additional cleaning services, per the map attached herein as Exhibit A.
- 3.1.3 **Quality:** All bids must meet the minimum specifications listed herein.
- 3.1.4 The City of Canton reserves the right to award multiple contracts as a result of this bid and to split the award between multiple vendors if it is in the best interest of the City to do so.

- 3.1.5 Non-Exclusivity: The City of Canton reserves the right to contract for the same or similar items covered in this bid from additional vendors not awarded contracts resulting from this bid if found to be in the best interest of the City.
- 3.1.6 The successful bidder shall be required to comply with the insurance requirements contained in the bid packet and resulting contract.
 - 3.1.6.1 Property Owner shall defend, indemnify and hold harmless Canton, its officers, agents, employees, successors and assigns from any and all claims, losses, costs, damages, expenses and liabilities, including reasonable attorney's fees, that may be based upon loss of life or damage or injury to any person or to the property of any person, including, without limitation, the agents, employees, invitees and licensees of Property Owner arising out of or connected to, either directly or indirectly to the performance of power washing or any other work done on the property in connection with this voucher.
- 3.1.7 The successful bidder shall perform all work in a workmanlike manner and shall observe and comply with all Federal, State and City of Canton laws, ordinances and regulations.
- 3.2 Exterior Residence Cleaning Specifications
 - 3.2.1 The successful bidder shall furnish all labor, equipment (in good repair), chemicals and materials for exterior residence cleaning services for the locations listed in Exhibit A, the designated area, and in accordance with the prices set forth on the proposal page.
 - 3.2.1.1 The list of exact addresses in the designated area of residences that are eligible to be cleaned is attached at Exhibit B-1 and Exhibit B-2.
 - 3.2.1.1.1 The locations listed in Exhibit B-2 may have extra deposition and may require the use of advanced cleaning methods such as scrubbing, cleansers, etc.
 - 3.2.2 There are a total of 516 residences in the designated area that are eligible to be cleaned, per the specifications contained herein. Per Exhibit B-2, 176 of those residences may have extra deposition and are eligible for advanced cleaning methods, as needed.
 - 3.2.2.1 The map shown in Exhibit A denotes the boundaries of the designated area eligible for cleaning, which is outlined in yellow. The Exhibit A Legend indicates the color scheme of the locations that may have extra deposition and may require advanced cleaning methods, as eligible for advanced cleaning, which are listed in Exhibit B-2.
 - 3.2.2.2 The successful bidder is responsible to perform advanced cleaning as necessary to ensure thorough cleaning of the residences that are eligible for advanced cleaning. All residence exterior cleanings shall include the cleaning of the gutters/spouting and the soffit of the residence.
 - 3.2.2.3 If the successful bidder identifies a home outside of the Exhibit A indicated or Exhibit B-2 listed locations that require advanced cleaning, they shall contact the

- 3.2.3 The successful bidder shall be responsible to provide storm sewer inlet protection which is required at nearby catch basins.
- 3.2.4 This exterior residence cleaning program will be administered by the City of Canton and the Canton City Public Health, Air Pollution Control Division.
- 3.2.5 The City of Canton and the Canton City Public Health will distribute a voucher to each location that is eligible for this cleaning program. The voucher will be valid for the cleaning of primary residences only. There shall be one voucher per address. The voucher is attached as Exhibit C.
 - 3.2.5.1 This program does not apply to businesses, outbuildings, roofs or detached garages. Garages that are attached to the home are eligible to be cleaned.
 - 3.2.5.2 This program applies to any rental residence, duplex, triplex, SMHA property, and/or mobile home within the neighborhoods provided in Exhibits A and B.
- 3.2.6 The property owners must call the successful bidder between April 1, 2024 and September 30, 2024 to schedule the cleaning of their residence, in order for the program to be completed by October 31, 2024.
 - 3.2.6.1 If the property owner chooses, they may have their residence driveway and sidewalk cleaned instead of their residence exterior. The sidewalk shall consist of both the public sidewalk and private sidewalk in front of and leading up to the house. For those addresses located on a corner, the public sidewalk to the side of the residence is also included. As noted on the voucher, the owners will have to choose one of these options for cleaning services.
 - 3.2.6.2 The pricing for the cleaning of driveways and sidewalks will be listed separately on the proposal page as an alternate bid item. The price of any alternate bid items will be taken into consideration when determining the lowest and best bidder.
 - 3.2.6.2 Cleaning of porches, patios, etc. will not be eligible for this project.
- 3.2.7 No cleanings will be performed after October 31, 2024.
- 3.2.8 This cleaning program shall be at no expense to the property owner, other than any additional services requested as detailed in 3.2.10. Payment will be processed by the City of Canton and the Canton City Public Health.
- 3.2.9 Property owners must provide their signed voucher to the successful bidder in order for the cleaning of their property to occur. The successful bidder is responsible to confirm the address listed on the voucher is on the list of addresses provided and that service has not already been provided for that address. The successful bidder shall not begin work, nor will they get paid, without the signed voucher from the property owner.

- 3.2.9.3 The successful bidder is responsible to keep track of expenses incurred to insure they do not exceed the awarded total contract. Costs incurred beyond the total awarded contract will not be paid for by the City of Canton.
- 3.2.10 The property owner may, at their own expense, arrange for additional services such as cleaning of outbuildings, garages, etc. at their home when they schedule their cleaning. Additional services will not be paid for by the City of Canton.
- 3.2.11 The successful bidder must submit all final and signed vouchers with invoices to the City of Canton and the Canton City Public Health by November 30, 2024 for payment.
- 3.2.12 The successful bidder must use only cleaning products that are recommended and approved by the Ohio Environmental Protection Agency.
- 3.2.13 All interested bidders are responsible to view the eligible locations listed in the attached Exhibits, in order to properly prepare their bid price as determined on the proposal page.
- 3.2.14 The successful bidder will be responsible for any damage caused to the owner's property and will return all aspects of their property to their original condition, or better.
- 3.2.15 Depending on available funds remaining after the initial cleaning program is complete, the City of Canton and the Canton City Public Health may contract for additional cleaning services, as needed. As a result, optional bid items are listed on the proposal page for potential consideration at a later date.
- 3.2.15.1 The potential optional bid items will be located in the same designated coverage area as all of the other cleaning services noted in this bid.
- 3.2.16 Optional Bid Items:
- 3.2.16.1 There is one optional bid item listed on the proposal page. The City of Canton and the Canton City Public Health may or may not award any or all of these optional items. This will be dependent on the availability of funds after the completion of the exterior residence cleanings per the base bid and as listed in the exhibits.
- 3.2.16.2 If any of the optional bid items are awarded, there will be a different invoicing process for those services. The optional bid items will not utilize the voucher program. They will use standard invoicing with payment due within 30 days of receipt of the invoice.

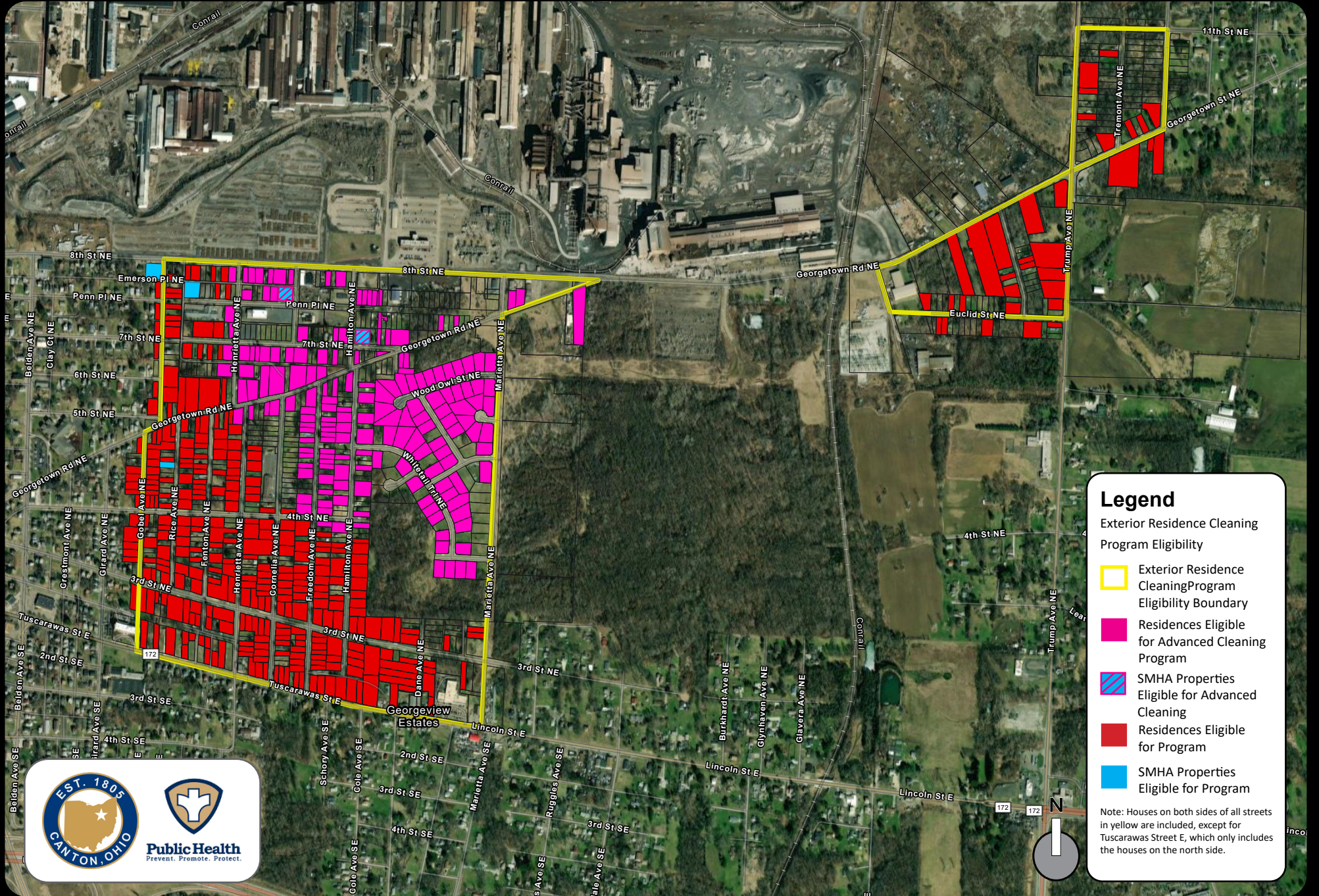
