1.0 WORK DESCRIPTION

The work will include furnishing labor, materials, equipment, tools, surveying, engineering, permitting and construction of sanitary sewer force main and gravity mains, two lift stations, two wastewater horizontal directional drills, new natural gas lines, two natural gas horizontal directional drills, and restoration of existing roadways, driveways, sidewalks and landscaping. These improvements will be constructed by the City of Lake City to provide wastewater improvements near the I-75 and SR 47 Interchange and to remove existing septic tanks from service in this area.

All work shall be in accordance with the construction drawings, specifications, and contract documents.

2.0 RECEIPT OF BIDS

Bids shall be completed on the enclosed Bid Form as set forth in the Instructions to Bidders and otherwise be in compliance with the Bidding Documents. Sealed bids shall be uploaded to ProcureNow at <https://secure.procurennow.com/portal/lcfla/projects/9198> no later than 2:00 P.M.

(local time) on Friday, May 28, 2021, at which time all bids will be read aloud from the City Council Chambers on Zoom at 2:00 p.m. For a link to attend the opening, please contact procurement@lcfla.com. Any Bids received after the specified time and date will not be considered.
