As a result of questions received during the Non-Mandatory Pre-Bid Meeting held on Tuesday, November 5, 2024, the following clarifications/changes are provided for your information. Please make all appropriate changes to your solicitation documents.

Question 1: Can the Bid Bond be submitted digitally, or does it need to be the original?

Response: If the Bid Bond can be digitally signed, and can be verified and recorded, the District can accept the electronic version. If it is paper, the District will need the paper original before the submittal date.

2. On page 26, under Section 1. TERM in Paragraph (c) Completion Date, the following change has been made:

“The Completion Date of this Agreement is **May 31, 2025**, unless extended by mutual written agreement of the parties. The Work shall be completed for use no later than said date.”

3. On page 4, under Section 2. Contract Administration, the Phone Number for Mark Morris, Associate Procurement Specialist, is corrected to **386-329-4264**.
