

Request For Bids Pre-K Storage Shed Installation

The School District of the City of Saginaw is currently requesting bids for the installation of storage sheds for the Pre-K Playgrounds at the locations listed below. Installation shall meet or exceed the specifications noted below. Typical measurements of existing playgrounds can be obtained via Google Maps or Saginaw GIS. Bidders shall visit sights during off-school hours to get measurements if needed, after 3:30 PM M-F or on weekends. The Pre-K playgrounds are the ones that are completely enclosed by their own independent fencing system.

Installation shall include placement determination, site preparation, fence and rubber mulch adjustments as needed, installation of concrete base, and installation of shed.

Shed shall be a minimum of 7'W X 7'D, preferred specification is UV resistant vinyl resin, with no windows, lockable doors, multi-layer and metal reinforced wall panels and metal hinges. Alternates will be considered but must meet preferred specifications. Accepted minimum specification is Craftsman CMXRSSC7750.

Concrete Pad shall accommodate the selected shed footprint and shed shall be secured to concrete pad. Minimum concrete pad depth of 4".

Concrete pad and shed shall be installed a minimum of 6 feet from any play equipment.

Concrete pad shall have no sharp edges or corners.

Fencing and rubber mulch shall be adjusted as needed by the contractor.

Installation shall be completed by September 3rd, 2024

Chester Miller and Handley locations do not currently have PreK Playgrounds, they will be installed this summer. Awarded Bidder shall coordinate with the installer to facilitate completion.

Henry Doerr PreK Playground will be getting additional equipment this summer. Awarded bidder shall coordinate with the installer to facilitate completion.

The Owner reserves the right to reject any, part of any or all bids and to waive all informalities in the bidding procedures. The Owner reserves the right to reject any bid when Bidder fails to submit data required by the Bidding Documents, or if the bid is submitted incomplete or irregular. No telephonic, telegraphic, email, fax bids or modification to a submitted bid will be received or considered by the Owner.

Each bid that exceeds Fifty Thousand Dollars (\$50,000) must be submitted with an attached certified check or bid bond from a surety company approved to do business in the State of Michigan, payable to the Owner in an amount not less than five percent (5%) of the base bid.

Bids may not be withdrawn for a period of sixty (60) days after the bid date.
