INVITATION FOR SEALED BIDS

Separate sealed BIDS for the "Structural Upgrade and Limited Architectural Improvements to 814 South Main Street" in the City of Columbia, Tennessee 38401 will be received at City Hall in the Office of the City Engineer in Conference Room A, 700 North Garden Street, Columbia, Tennessee, 38401, until 2:30 p.m., C.S.T., local time, on Wednesday, February 25th, 2015 and then at said place publicly opened and read aloud.

In general, the WORK to be done consists of providing labor, materials, equipment, insurance and bonds, and will include the following:

An existing downtown Columbia structure, involved in a partial building collapse September 2013, will be partially renovated to improve structural and architectural aspects of the building. This building is located at 814 South Main Street in Columbia, Tennessee. The Contractor shall perform a new front facade reconstruction, and rebuild certain areas damaged by the partial collapse as described per the drawings prepared by Nuber Architecture, LLC.

- 1. Remove portions of the existing main level and second level floor system damaged in the collapse.
- 2. Rebuild a small amount of the north and south brick party walls which were affected by the collapse.
- 3. Construct a new front facade with metal studs and brick veneer and install new windows and entrance door.
- 4. Complete roof framing damaged in the collapse and install a new TPO membrane roof over the original structure.
- 5. Provide new LVL floor structure on main floor and second floor levels in the front portion of the original structure and sheath accordingly.
- 6. As a part of Alternate #1, provide a roof tear off and fascia removal of the existing CMU garage addition and install a new TPO membrane roof and fascia reconstruction.
- 7. No mechanical, electrical, or plumbing is a part of this work scope unless noted otherwise in the construction documents.
- 8. This project is not intended to finish out the interior of the building as the city of Columbia is only interested in providing a weathertight structure and new front facade at this point.

No BIDS will be received or accepted after the above specified time for the opening of BIDS. BIDS submitted after the designated hour will be deemed invalid and returned unopened to the Bidder.

The SUCCESSFUL BIDDER will be required to furnish an acceptable PERFORMANCE AND PAYMENT BOND, each in the amount one hundred percent (100%) of the CONTRACT price.

No Bidder may withdraw his BID within thirty (30) days after the actual BID date of the opening thereof.

All Bidders must be licensed CONTRACTORS to perform the type construction herein described as required by Tennessee Code Annotated. BIDS must be submitted at the time and place indicated in the INVITATION TO BIDDERS and shall be included in a sealed envelope marked as follows:

Project title, Bidder's name and address, Bidder's Tennessee CONTRACTORS License Number and Expiration Date, Bidder's License Classifications, and Contract for which BID is enclosed.
