The City of Springfield, Tennessee will receive separate sealed bids for the Springfield Water Treatment Plant Flocculation-Sedimentation Basin Crack Repair project at the Office of the City Recorder at City Hall, 405 North Main Street, Springfield, Tennessee 37172 until **2:00 p.m.** local time on **Thursday, September 8, 2016**, and, then, at said time, publicly open and read the bids aloud. Any bids received after 2:00 p.m. local time on Thursday, September 8, 2016 will not be opened and will be rejected. The outside of the sealed envelope shall include the **Bid Number 985** and shall clearly indicate that the sealed envelope contains a bid for a water treatment plant project.

The work to be bid on is generally as follows:

The project generally consists of repairing cracks and other structural defects in the concrete flocculation-sedimentation basin at the Springfield Water Treatment Plant. The work will take place on the outside face of the basin's four exterior walls. Two walls are outdoor, one wall is indoor (in the pipe gallery), and one wall is partially indoor (part of a pipe chase accessed through the chemical feed room) and partially outdoor. The work includes surface preparation to remove all existing coatings, sealants, and other deleterious materials to provide a clean absorbent surface; repair of cracks with and without active leaks; repair of construction joints as necessary; repair of structural defects such as honeycombing and rock pockets as necessary; and the application of a crystalline waterproofing system, all in accordance with the manufacturer's recommendations. The contractor and any subcontractors must have a minimum of five (5) years of experience on projects of similar size and complexity.

The allotted time for construction is **60** calendar days.
