- Scope of Work:**
- The Tallmadge Fire Department (TFD) has targeted ensuring the health and safety of its employees as the key objective. The organization believes that an essential method to achieving this objective is to implement a mental health and well-being training program.
- The program requires a provider with extensive experience in the job-related tasks, stressors, requirements, and work-life balance encountered by first responders.
- OBJECTIVES**
- a) Provide in-person workshop-type training for employees that provides education on topics such as, but not limited to, suicide prevention/awareness, signs/symptoms, behaviors, PTSD, etc.
 - b) Provide in-person workshop-style training in the topics listed above for spouses/partners/significant others, of first responders.
 - c) Provide employees with tools to promote emotional wellness.
- SCOPE OF WORK**
- The provider will provide two 8-hour training courses over the scope of this award period to begin immediately following the award and in the fourth quarter of 2024. The provider must be knowledgeable of issues specific to emergency responders. Sessions will be allowed to be recorded for mandatory viewing by members unable to attend in-person training.
- Timeline:** Upon execution of an Agreement for Services, the provider will schedule for full delivery of services within 30 calendar days.
- Appraiser Qualifications:** The provider must be knowledgeable about the current issue regarding first responder mental health wellness including but not limited to suicide, suicide prevention, PTSD, moral injury, and family implications.
