### CITY OF BELLE MEADE STREET SWEEPING CONTRACT DECEMBER 1, 2020 – NOVEMBER 30, 2022

#### INFORMATION FOR BIDDERS

#### A. INVITATION FOR BIDS

Sealed bids for a 2-year contract for monthly street sweeping of all city streets within Belle Meade city limits will be accepted at Belle Meade City Hall, 4705 Harding Road, Nashville, TN 37205 (615-297-6041) on or before 11:00 am CST on Tuesday, September 8, 2020, at which time said bids will be publicly opened and read aloud.

The City reserves the right to waive informalities and to reject any and all bids.

#### B. INFORMATION FOR BIDDERS

The City of Belle Meade, Tennessee solicits bids for a two (2) year contract for street sweeping of all streets, which includes the following:

- 1. Provide once a month service for removal of regular, day-to-day build-up of material and debris, an area 7 feet wide from the paved shoulder edge, within the City of Belle Meade.
- 2. Any excessive, out of the ordinary, or unusual build-up or residue of any dirt, debris or material is covered by the price quoted in this agreement under the hourly rate. These items include leaves, deeper than one-half the height of the curb face, debris or material as a result of construction work, or a large amount of debris or material from a storm, high winds, lightning, or flooding. By mutual agreement, these items may be cleaned up at the hourly rate plus disposal.
- 3. Emergency removal of a build-up of material and debris as directed by the City Manager or Public Works Director at an established hourly rate. The City requires a two (2) hour maximum response time unless otherwise directed.
- Sealed bids will be received by the City of Belle Meade, online via the City website or at City Hall, 4705 Harding Road, Nashville, Tennessee 37205 at or before 11:00 a.m. CST, Tuesday, September 8, 2020, at which time they will be publicly opened and read aloud.
- 5. Bids must be submitted on the Bid Forms enclosed, with Schedules I IV, attached.
- 6. No Bidder may withdraw a submitted bid for a period of 60 days after the date set for the opening of bids. The City reserves the right to accept any bid or reject any and/or all bids.

#### C. <u>CONDITIONS</u>

- 1. Indemnity and Insurance Requirements It is specifically understood and agreed between the parties that the Contractor shall indemnify City, defend and save it harmless against any and all claims, causes of action and/or suits which may be presented or brought, arising out of the conduct of the Contractor or any of its employees, servants or agents or subcontractors, in the performance of this agreement. In furtherance of this agreement for indemnity, but not by way of limitation thereof, Contractor shall obtain and keep in effect during the term hereof, and any extension, at his own expense, policies of insurance, indemnifying itself, and the City against all claims, causes of action and other liabilities or whatsoever kind and nature arising out of, or in any way connected with its activities pursuant to this contract, such insurance to cover:
- Workers Compensation benefits as required under the statutory limits for the State of Tennessee.
- General Liability to include damages for Bodily Injury, Property Damage, and Personal Injury in the amount of one million dollars (\$1,000,000) per occurrence with a two million dollar (\$2,000,000) annual aggregate.
- Automobile Liability to include owned, hired, and non-owned motor vehicles in the amount of one million dollars (\$1,000,000) per occurrence.
  - IN ADDITION to Insurance Certificates for the above coverages, an ENDORSEMENT NAMING THE CITY OF BELLE MEADE AS AN ADDITIONAL INSURED is required for the Liability and Automobile coverages.
- Bidder shall be required to satisfy the City Manager and Public Works Director that
  they have adequate equipment and experience to perform the contract. At a
  minimum, bidder must certify that he has back-up equipment to replace the
  equipment normally used to perform the contract
- 3. The City has a right to cancel this contract on thirty (30) days written notice for failure of bidder to properly perform the duties herein.
- 4. The successful bidder shall enter into a written contract by December 1, 2020 or the first business day of December and provide evidence of insurance at that time (or pre-agreed later date).
- 5. The term of the initial contract would be for two (2) years, beginning December 1, 2020. After completion of the initial contract period, the contract may be renewed for a period not to exceed one (1) year per renewal up to two (2) years upon written confirmation from the City and the Contractor. <u>The per mile and per hour cost will be adjusted at renewal time using the Consumer Price Index based on any increase or decrease in the Transportation Index.</u>
- 6. No cleaning operation shall be conducted when there are climatic conditions present or forecast that would make such an operation ineffectual or dangerous. The climatic conditions include, but are not limited to, heavy rain, fog, snow, ice, sleet, and high winds.
- 7. At no time shall sweeping be performed against the flow of traffic.

#### D. QUALIFICATIONS

Bidder must demonstrate to the City he has the following:

- 1. A minimum of three (3) years' experience in the street sweeping business and provide three (3) references of same.
- 2. The Bidder must use operators possessing a commercial driver's license, pass a pre-hire drug screen, and be subject to an annual random drug and alcohol screen.
- 3. Evidence Bidder has shop facilities and an office with receptionist or a mobile phone from 8:00 a.m. to 5:00 p.m., Monday through Friday. Additional telephone numbers and personnel must be provided in case of an emergency.
- 4. Certificate of liability insurance and workers' compensation insurance, as described in Section C, Conditions.
- 5. All equipment must meet minimum safety standards as outlined by the Department of Transportation regarding strobe lights, arrow board, and, if applicable, use of a shadow vehicle with an arrow board and impact attenuator.
- 6. This agreement shall not be assigned by the Contractor, except upon the express prior written consent of the City.
