1.0 Introduction

The Sullivan County Purchasing Department on behalf of the Sullivan County Sheriff's Office is seeking bid proposals for a sewage grinder. Bids are to be submitted no later than **Wednesday, May 10, 2017 at 2:00 pm** in a sealed envelope clearly identified "**RFP #54117(KD) Sewage Grinder**" and bid due date and time marked on outside of envelope.

1.1 Scope of Work

Sullivan County is seeking to purchase a sewage grinder to include installation for the Sheriff's Office located at 140 Blountville Bypass, Blountville, TN. These specifications are for a Franklin Miller Taskmaster Grinder, Model TM8512 (**or equal**). (**If bidding an alternate, complete specifications must be submitted with bid proposal**).
