- 1.6 Bidders, their agents and associates shall not solicit any County Official and shall not contact any County Official other than the Designated Purchasing Contact of this ITB for additional information and clarification.
- 1.7 All timely Bids meeting the specifications set forth in this ITB will be considered. However, Bidders are cautioned to clearly indicate any deviations from these specifications. - 1.26 MISUNDERSTANDINGS: The failure or omission of the Bidder to receive or examine any instruction or document, or any part of the specifications, or to visit the site and acquaint themselves as to the nature and location of the work (where applicable), the general and local conditions, and all matters which may in any way affect performance shall not relieve the Bidder of any obligation to perform as specified herein. - 2.2 To issue additional subsequent ITBs or RFPs.
- 2.3 To reject all incomplete / non-responsive Bids, or Bids with errors.
- 2.4 The County reserves the right to determine, in its sole discretion, whether any aspect of the submitted Bids is satisfactory to meet the criteria established in this ITB, the right to seek clarification and/or additional information from any submitting Bidder.
- 2.5 The County shall have no liability to any Bidder for any costs or expenses incurred in

- connection with the preparation and submittal of a Bid in response to this ITB.
- 2.6 If the County believes that collusion exists among Bidders, all Bids will be rejected.
- 2.7 Highlands County, Florida reserves the right, in its sole discretion, to remove parcels from the sale and to reject any or all bids submitted. The winning bidder is responsible for: Documentary tax on the Deed (.70 per \$100), recording fees (approximately \$18.50), and auction fee (7.5% of sales price). 




ROLAND ST NW FACING SOUTH
