THE MINIMUM SPECIFICATIONS ARE, BUT NOT LIMITED TO THE FOLLOWING:

- Engine shall be minimum of 340 CID 6 cylinder Turbo Charged Direct injected 4 stroke Diesel. EPA Tier4/Stage 111A compliant
- Horse power shall be at least 120 – Net SAE J1349
- Fuel tank 50 gallon minimum
- 110 Volt engine block heater
- Transmission: power shift, hydrostatic or automatic
- Final Drives: Outboard mounted planetary with full float axles
- Front Axle: Fixed with manually operated 100% differential lock
- Rear Axle: Minimum 12% oscillation from center of pivot
- Differentials: limited slip, no spin, or torque proportioning
- Transmission Gears: Minimum of four forward and reverse
- Operating weight: Max of 28,000 lbs. based on standard 3yd general purpose bucket and conventional tires.
- Minimum 3.0 cubic yd. Refuse bucket with dual top clamps, grapple design, with grid covering 80% of bucket area, bucket shall be quick attach type to incorporate other attachments.
- Breakout force: 18,000 lb. minimum based on standard 3yd general purpose bucket.
- Solid rubber tires & rims, Manufactured by Setco with inner shroud.
- Power brakes & power steering with minimum 40 degree articulation while turning
- Standard factory parking brakes with warning system
- Factory cab must meet all OSHA & ANSI regulations. Heater, defroster, horn, factory air conditioning, factory AM-FM radio, dual mirrors, wipers front & rear, operating lights, turn signals, brake lights, safety flashers, flashing beacon light, telescopic tilt steering wheel, factory tachometer, hour meter, adjustable seat, standard instrument panel, and rear view camera.

- Automatic bucket leveler with indicator
