This is a one-time purchase.

## Detailed Requirements:

I need a quote on a Multi Dome Hip Shade with the following requirements:

1. 90 x20 x 8.5 ft entry height and 8 ft above surfacing consists of 3 domes each.
2. Domes: 30 x 20 x 8.5 entry height and 8 ft above surfacing.
3. 8 Columns on base plates 05.5" Sch-40. Rafters at 03.5" 11-Ga with glide elbows.
