

The Court further finds that, based upon the testimony of Glen Cofer, Roane County Building Inspector and Codes Enforcement Officer, and photographs submitted as exhibits to his testimony, the aforesaid real estate remains overgrown, in violation of Resolution No. 01-14-03, and the unsafe structure, a fire-damaged building described in the aforesaid June 12, 2018 Order, remains on the aforesaid property.


Therefore, the Court finds that the Motion of the Plaintiff for an injunction should be sustained, and the Court **ORDERS, ADJUDGES and DECREES** that the following mandatory injunction is heretofore **ORDERED**:

1. Plaintiff, Roane County, Tennessee, its employees, agents, contractors and assigns, are hereby authorized and empowered to enter upon the property of the Defendant, Janice C. Cofer, at 1225 Eureka Road, Rockwood, Tennessee, as described in the Roane County Register's Office in Deed Book E, Series 22, Page 250, and as described in the Roane County Property Assessor's Office as 64E/C/64E/1.00, and to engage in all activities necessary to demolish the unsafe fire-damaged building located thereon and properly dispose of the debris resulting therefrom, and to further engage in all activities necessary to bring said real estate into compliance with Roane County Resolution Number 01-14-03, prohibiting overgrown and dirty lots, including, but not limited to, collecting and removing all debris, junk, personal property or other items located thereon.


2. Plaintiff, Roane County, Tennessee, its employees, agents, contractors and assigns, are further empowered to remove all obstructions and barriers preventing access to the aforesaid property in order to carry out the duties, obligations and activities authorized by this Order and the prior **ORDERS** of this Court.

3. The Roane County Sheriff's Office is hereby **ORDERED** and authorized to provide one or more deputies on the aforesaid real estate at all times while said real estate is being entered upon and brought into compliance with the terms of this Order and the prior **ORDERS** of this Court, to enforce the terms of this Order and to prevent any breach of the peace while said activities are in progress.


