Sealed bids for Flashing Yellow Arrow Signalization Improvements CMAQ-7304(605) and Accessible Pedestrian Signalization Improvements will be received at: City Hall, 310 W Pearce Blvd, Wentzville, MO 63385 until 2:00 o'clock P.M. (Prevailing Local Time) on the 3<sup>rd</sup> day of February 2017, at the Wentzville City Hall, and at that time will be publicly opened and read. All bids shall be submitted in the form of Sealed Bid. Bids must be submitted in a sealed envelope, and must be clearly marked on the outside of the envelope with the following:

The proposed work includes:

The Flashing Yellow Arrow (FYA) Signalization Improvements consist of the replacement of traffic signal heads, with flashing yellow arrow indicators at 10 signalized intersections along all arterial and collector routes within the City of Wentzville. Related to this conversion are the replacement of conflict monitor devices to FYA compliant Malfunction Management Units, traffic control cabinet modifications, and replacement of MUTCD / ADA compliant Countdown Pedestrian Heads, and the upgrade of deficient detection equipment.

The Accessible Pedestrian Signalization Improvements consists of the upgrade of ADA facilities at several City of Wentzville signalized intersections including curb ramps, audible / vibrotactile push buttons. Additionally, the project includes the installation of battery backup systems at each signalized intersection.

A pre-bid conference will be held at 9:00 AM on the 20<sup>th</sup> day of January 2017, at Wentzville City Hall at 310 West Pearce Blvd. Wentzville, MO 63385. Attendance at the pre-bid meeting is **ENCOURAGED** but not mandatory.

Bid documents will be distributed electronically via an FTP link at no cost. Bidders may make printed copies of the bid packet which include specifications, drawings, and bid documents at their own expense. When requesting the FTP link, you will be required to provide your name and company information for the planholder's list and furnish an email address for receiving official bidding communications and addenda. Communications between the bidders and the City shall be conducted and documented in writing through the use of e-mail communication. No oral interpretation will be recognized.

A set of the bid documents and plans are available for public inspection at Wentzville City Hall, 310 W. Pearce Blvd., Wentzville, MO 63385. The official Plan Holders List will be maintained by the City of Wentzville Procurement Department. It is the responsibility of all Bidders and plan holders to submit their contact data to the Wentzville Procurement Department to be placed on the Plan Holder List, regardless of the bid document source.

All labor used in the construction of this public improvement shall be paid a wage no less than the prevailing hourly rate of wages of work of a similar character in this locality as established by the Department of Labor and Industrial Relations (Federal Wage Rate), or state wage rate, whichever is higher.

The City of Wentzville hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award.

All bidders must be on MoDOT's Qualified Contractor List per Section 102.2 of the Missouri Standard Specifications for Highway Construction, 2011 Edition including all revisions. The contractor questionnaire must be on file 7 days prior to bid opening.

Contractors and sub-contractors who sign a contract to work on public works project provide a 10-Hour OSHA construction safety program, or similar program approved by the Department of Labor and Industrial Relations, to be completed by their on-site employees within sixty (60) days of beginning work on the construction project.

A certified or cashier's check or a bid bond in the amount of 5% shall be submitted with each proposal.

The City of Wentzville reserves the right to reject any or all bids.

The DBE Goal for the Flashing Yellow Arrow Signalization Improvements and for the Accessible Pedestrian Signalization Improvements is 8%.

No 2<sup>nd</sup> tier subcontracting will be allowed on this project.
