The City of Springfield, TN is requesting the submission of bids for chemicals to be delivered as needed to the Springfield Water Treatment Plant 6213 Smith Rd. Cedar Hill, TN 37032.

All prices shall be good for calendar year 2025.

All chemicals must be approved by the EPA and/or be listed with the National Sanitation Foundation (NSF) for use in the treatment of potable water and meet specified requirements as listed for each individual chemical.

These specification sheets contain information regarding the chemicals that are used, including the specific chemical, plant storage capacity and estimated yearly usage.

Activated carbon (either 40- or 50-pound bags)

Delivery shall not be greater than 50 bags per pallet.

Aluminum chlorohydrate (Aqua Hawk-607)

Must have the ability to fill one 1,300-gallon tank from mini-bulk or bulk delivery. Tank loads from top hatch. Must have at least 75 feet of hose. Deliveries shall be received within 5 days of order being placed.

Aluminum sulfate (liquid, tanker load)

Product shall be bid per pound dry weight. Tank has 2.5 inch cam lock connection. Deliveries shall be received within 5 days of order being placed.

Sodium Hypochlorite (Bleach 12-12.5%)

Must have the ability to fill tank (from as low as 500 up to 3,000 gallons) from mini-bulk or bulk deliveries. Tank has 2.5 inch cam lock connection. Deliveries shall be received within 5 days of order being placed.

Hydrated lime (50-pound bags)

Delivery shall not be greater than 50 bags per pallet.

Hydrofluorosilicic acid 23-25% (55-gallon drums)

Delivery shall be within 1 week of order being placed.

Polyphosphate (Mini-bulk or bulk delivery as needed)

Must have the ability to fill a 900 gallon tank from mini-bulk or bulk delivery. Tank has 2.5 inch cam lock connection. Orders shall be received within 1 week of order being placed.
