PART A

SPECIAL PROVISIONS NE 34TH AVENUE ROADWAY IMPROVEMENTS FPID NO. 438563-1-54-01 AND 438563-1-54-02

- SP-1 Section VI (insert items from Bid Documents expected to be a part of the contract) of the Bid Package are incorporated by reference and shall be considered as part of the contract documents as if included herein.
- SP-2 Contractor shall confine all activities to the maintained ROW of Okeechobee County. Any staging or stockpile areas outside the ROW shall be considered offsite and must be coordinated with the property owner. Prior to use of offsite areas the contractor shall obtain and provide to the County written permission from the property agreeing to use of the property. Contractor shall be responsible for any permits and/or erosion control needed for use of the property and provide any restoration needed to return the property to its original condition upon termination of use. Contractor shall indemnify and hold harmless the County against any adverse impacts or claims as a result of the contractor's use of that property.
- SP-3 Okeechobee County shall have ultimate authority on the project. Any reference to "Department" or "FDOT" in these contract documents, whether standard documents included by reference or explicitly included herein, shall be considered as meaning Okeechobee County. Where Okeechobee County requirements conflict with referenced FDOT requirements, the County requirements shall supersede.
