**1.0 GENERAL INFORMATION**

This specification is for the purchase of four (4) knife gate valves to replace the existing valves and for use with the existing actuation equipment. The Moccasin Bend Wastewater Treatment Plant currently uses four DeZurik knife gate valves to control the flow at the wet weather grit removal tanks. This specification describes the type of knife gate valve replacement needed and is for the valve only. The City is taking bids on four (4) replacement knife gate valves.

**2.0 GENERAL SPECIFICATIONS KNIFE GATE VALVE**

- 2.1 Style - Cast Knife Gate Valve
- 2.2 Size - 36 Inch (900mm)
- 2.3 Body Style - Extended Service Valve
- 2.4 End Connection - Flanged Drilling; ASME Class 150
- 2.5 Body Material - 304 Stainless Steel Cast
- 2.6 Packing - PTFE Braided Packing to 500° F. (260° C.); (pH Range 0-14)
- 2.7 Gate Material - 304 Stainless Steel
- 2.8 Seat Material - Chloroprene to 180° F. (83° C.)
- 2.9 Coating or Paint: 4G0 - 3 mils minimum (non-stainless steel parts) of Black Enamel on Exterior and Standard (SP10) surface prep
- 2.10 A minimum 1 year warranty is required
