This is a Mandatory Pre-bid meeting Jackie Robinson Training Complex – Villas Remodel, Bidders must sign in before 10:00 A.M. to receive credit for attending. **Meeting started** at 10:10 due to the change in venue for the meeting.

PROJECT DESCRIPTION:

Project consists of interior renovations to 57 existing hotel-style rooms located at Jackie Robinson Training Complex. These renovations include the removal and replacement of floor coverings, patching and selected replacement of dry wall ceilings, removal of popcorn ceilings, the removal and replacement of front windows, HEPA vacuum and clean all surfaces to rid space of mold. Project is also to include the removal of existing HVAC duct work above the ceiling, and installation of new insulated, fire rated attic access panels.

GENERAL: REGULAR ROOMS, SMALL ROOMS, SUITES

Remove any drywall due to moisture damage.

- There may be intermittent mold in bathrooms or other walls that was not indicated on the plans remove by standard acceptable mold remediation technique or replacement of drywall. Cost for some mold remediation work and/or drywall replacement should be included in the bid for all rooms. No additional compensation will be allowed for mold remediation, even if it is not known and encountered during construction.
- All front windows in 87 villa rooms and 1 housekeeping room and 2 back windows are to be replaced with new fixed windows.
- Ceilings an alternate is provided in the bid for 3 options to mitigate asbestos that was detected in the popcorn ceilings.

UTILITIES

Electrical – Minor electrical work required, exhaust fans, transom light demo. Alternate for PTAC Power connection.

Mechanical System – Alternate for removal of existing mini-split A/C units and installation of PTAC unit installation. **This includes the removal of the existing duct work above the ceiling.**

OTHER ISSUES

- The Contractor shall have someone on call and ready to respond within 30 minutes in case of emergency.
- The construction limits are within 10 feet maximum of buildings unless indicated otherwise.
- The construction staging area shall have 8'-0" high chain link perimeter fencing. Location shall be coordinated in the field with the Owner's representative
- Work area is to remain clean and all debris to be disposed of properly.
- Obtain all required Indian River County Building Department Permit(s) and inspections.

IRC Building Permit number 2021080629 has been approved and will be ready for pick up when Contractor is selected. The County will pay fees.

 Standard work hours for this project will be 7 a.m. to 5 p.m. Monday through Friday, and weekends as needed, Contractor must submit a request to the County Project Manager for proposed weekend or night work.

PROJECT REQUIREMENTS:

- Summary of required Contractor form submittals checklist (Section 00300 Bid Package Content)
- Invoicing shall be submitted on monthly basis and must include release of liens and Surety's Consent.

DISCUSSION/QUESTIONS & ANSWERS

Question: Will ColorWheel Paints be accepted if submitted by contractor?

Answer: Paint has been selected to match existing rooms that have recently been painted and not part of this project.

Question: Will there be any time extension for delivery of windows and other materials?

Answer: No. Bid project assuming 120 day for substantial completion.

Question: Should we assume there is mold in all 57 rooms?

Answer: Yes.

Question: Will there be sub-permits for work?

Answer: If any additional permits are required, the County will pay for them. Bidders should not

include any permit fees payable by Indian River County in their bid.

Question: Will product substitution be considered?

Answer: Substitution will only be considered after award of bid.

Question: Will air quality testing be performed prior to release of rooms?

Answer: Yes. County is contracting with consultant to conduct tests. At County's expense.

Question: Are post remediation tests for asbestos required?

Answer: County staff will check with Air Quality and Asbestos consultants.

Question: What is the window material?

Answer: Aluminum.

Question: The specified PTAC unit is no longer available? **Answer:** *New units will be specified in an addendum.*

Question: Can Contractor work on more than one group of rooms at a time?

Answer: Yes. All 57 rooms are available to be worked on.

Question: When can subcontractors view the rooms?

Answer: Sub-Contractors may visit the project site between 8 am and 12 pm on Tuesday 9-21-2021. All appointments outside of that time range must be coordinated through the Purchasing Division.

Comments:

32 units were recently renovated – those rooms will have new windows installed and potentially popcorn ceiling removed.

Asbestos survey is included with the bidding documents. Revision to this document has been made and will be provided with the addendum.

John Binkley from EDB reminded bidders to make sure they have all the required forms completed and turned in prior to the due date and time.

Bids will be opened publicly.
