Specifications for Resurfacing Tennis Courts in Decatur, Alabama

Scope: Repair and resurface tennis courts at multiple sites in Decatur, Al.

*Project to be completed between May 10th and August 12th, 2022.

Surface Preparation: Clean the area to be surfaced with high pressure washer as necessary to remove any loose material, dirt, stains and mildew.

Repair Cracks and Puddles: All cracks shall be filled with Plexipave Crack Filler, as manufactured by California Products Corp (or equivalent). Any low places which hold water deeper than 1/8 inch shall be filled with Court Patch Mix. After all patching and crack filling, thoroughly sand the courts with a power sander to remove rough edges and imperfections.

Crack Membrane System: At designated locations install the Riteway Crack Membrane system (or equivalent) as per manufacturer's guidelines over the existing structural cracks. The estimated linear feet of cracks to be covered is 3262 linear feet. Contractor is responsible for verifying the length of all cracks.

Acrylic Resurfacer: Over the properly prepared surface apply one layer of Plexipave Acrylic Resurfacer (or equivalent). This material is to be used as a filler coating to reduce porosity and obtain a uniform texture prior to applying the colored surface.

Colored Wearing Surface: Over the Acrylic Resurfacer apply a minimum of two layers of Fortified Plexipave (or equivalent) in accordance with the manufacturer's guidelines.

Colors: The colors shall be a <u>US Open Blue</u> playing area with a <u>US Open green</u> border.

Lines: White lines conforming to U.S. Tennis Association specifications shall be painted using 100% Acrylic Latex Plexicolor Line Paint (or equivalent) applied by brush and using masking tape.

Net Posts: Net posts shall be sanded and painted with a black, high quality enamel paint. Net posts should also be inspected for structural integrity and replaced where necessary.

Nets: Nets that are missing or damaged will be replaced with Six Star II or Edwards 40 LS net.

Contractor Qualifications: The contractor shall have a minimum of ten (10) years of experience in tennis court construction and shall be approved by the manufacturer of the materials to be used. The contractor shall also be a Certified Tennis Court Builder as designated by the American Sports Builders Association (ASBA). The Certified Tennis Court Builder must be an employee of the Tennis Court Contractor and shall oversee all phases of the resurfacing process.

Licensing: The successful bidder must obtain all necessary state and local licenses prior to bidding the project. Any contracts over \$50,000 require a State of Alabama General Contractor's License with appropriate limits and designation.

Weather Conditions: All work must be done when the temperature is above 60 degrees F.

Base Bid

The Base Bid will include the courts at the following locations. Jimmy Johns Tennis Center (18 courts), Wilson Morgan (6 courts), Delano Park (4 courts), Julian Harris Park (2 courts), Carrie Mathews Park (2 courts), Austin Middle School (3 tennis courts to be converted to 6 Pickle ball courts), and Pop Oliver Park (1 tennis court converted to 2 Pickle ball courts).

All cracks at Jimmy John's, Wilson Morgan and Delano will be repaired with the Riteway Crack Membrane System (or equivalent).

All cracks at Julian Harris, Carrie Mathews, Austin Middle School, and Pop Oliver Park will be repaired with the Plexipave Crack Filler (or equivalent).

Austin Middle School (3 courts) and Pop Oliver Park (1 court) will be converted into eight Pickle ball courts. The tennis posts and nets will remain as a backstop for the Pickle ball courts. A Pickle ball court will be placed on each side of the tennis court (2 per court). Permanent Pickle ball posts and nets will be installed. The Pickle ball courts will be colored <u>US Open Blue</u> inside the lines and <u>US Open Green</u> on the outside. The "Kitchen" area of the courts will be painted Red. The Wilson Morgan courts will be fitted with six foot high black "Tuffy Windscreen". Windscreens will be installed along the back and two sections of the sides on all six courts. "Tuffy" windscreen is a 10 oz. microfiber fabric with lockstitch hems and will require 680 linear feet.

If an "equivalent" product to Plexipave/Plexicolor will be used, contractor should provide the name of the equivalent product in the bid. All products should come from the same manufacturer.

Alternate bids

Alternate bids will be given for Walter Jackson Park (2 courts) and Flint City Park (4 courts).

All cracks at these courts will be repaired with the Plexipave Crack Filler (or equivalent).
