ADD the following:

QUESTION: Only 6,420 SF of Floor tile in addition to the unspecified quantity of mastic behind the Bulletin boards in 7 classrooms are to be priced for removal?

**ANSWER: The scope of work has the correct quantities. There is one layer of ACM VCT with either carpet or a new layer of VCT covering it.
4,928 square feet of carpet over one layer of VCT
1,492 square feet of 12" VCT over one layer of VCT
648 square feet of mastic on the walls**

These quantities are located in 7 classrooms and 3 office areas.
