The solicitation is amended as provided herein. Information or changes resulting from questions will be shown in a question-and-answer format. Questions received have been reprinted below. The "District's response" should be read without reference to the questions. The questions are included solely to provide a cross-reference to the potential offeror that submitted the question. Questions do not form a part of the contract; the "District's response" does. Any restatement of part or all of an existing provision of the solicitation in an answer does not modify the original provision.

#### **THE FOLLOWING INFORMATION SHALL BE INCORPORATED AS PART OF THIS SOLICITATION:**

**Q:** Daktronics has available an option for lifetime Cellular with Verizon for communications to an LED sign. In the specifications for new digital sign it does not mention this coverage. Was this coverage to be quoted?

**A:** **The digital signs shall have a wireless antenna communicating with the school. Contractor must install this system. No Verizon...**

**Q:** Seven-year manufacture's workmanship warranty (that is supposed to be for parts) Seven-year labor warranty. However, it does not state manufacture's labor warranty or if there is a deductible. Reason for questions many companies are trying to compete with Vantage LED Warranty of 7 year parts and 7 year on site labor warranty with no deductible. If a bidder is a sign company and they giving the 7 year warranty, it makes a big difference should they go out of business. Daktronics website is currently only showing a five year warranty?

**A:** **Seven (7) year parts and labor warranty is what we are requiring.**
