If there is a current contract for this service with another vendor could you please send this to me? Another question I have is whether you have an idea about the frequency of pickups needed because this would affect our pricing since we are required to pay a gate fee ourselves to the treatment plant that would incinerate the animals

Answer 1: Current contract price sheet is attached hereto as Exhibit 1. The Contractor shall perform dead animal collection services on an as-needed basis. The City spends from \$10,720 up to \$14,500 a year in the past 5 years, not inclusing pickup on private properties due to the property owner is responsible for paying the fees.
