<b>(NES) Please explain how you will notify the City when the collection is completed.:</b> We have an online form to show completions with descriptions on each pick up. The city may have full access, we can set up an automatic email to send upon pick up or we can call in after the animal has been retrieved. Our average response time is under 60 minutes.

<b>(PAL) Please explain how you will notify the City when the collection is completed.:</b> PALS documents every call in a log, with the date, time, person calling it in, animal type, location and call back person information. Calls are documented as to whether they are retrieved or not located. All call logs are emailed to the municipality with the monthly billing so the City may audit and verify charges. This is the current practice for all Cities including Phoenix, Glendale, Surprise, and Peoria.						
<b>(PAL) Phone numbers for collection, please include phone number for regular, afterhours and emergency:</b> We have one main number used for all collection calls. This number is 602-455-6677. We have live people answering the line from 7am to 6pm Monday through Friday and 8am through 4pm on Saturday. Outside of normal business hours, we always have an on-call person retrieving messages and answering calls, 24 hours a day, 365 days a year. All calls are returned within 10 minutes of a message being left. Additionally, we provide a 24/7 /365 emergency contact number which may be called in cases of emergency. That number is 602-503-6827.
