1. Will these devices have any etching or engraving on them?  
**No**
2. Will they be free from passwords, iCloud locked or managed?  
**The devices should be free from passwords; we did not manage them with an MDM.**
3. What date will the awarded bidder be able to pick up the devices?  
**August 15, 2018 or after**
4. What is the address of the location of the iPads?  
**2171 West Main Street, Rock Hill, SC 29732**
5. Does that location have a loading dock?  
**Yes**
6. How are the devices stored now?  
**The devices are stored in large boxes.**
7. Did they have cases on them during use?  
**Yes**
8. Will you have the charging bricks and fire wire cables?  
**We do have some cables and bricks. These items have not been counted.**
9. Will there be one charger and cable per device?  
**No**

10. What is the general conditions of the devices? Can you send pictures of them?  
**As stated on the quote. Some pads are in good condition and others are damaged. No, we can't send pictures of them.**
