The City of Avondale (the "City") Neighborhood and Family Services ("NFS") is seeking a licensed and qualified Contractor to provide all material and labor required as described below on an as-needed basis for a period of one year, with four automatic renewable one-year options.

Contractor shall provide commercial equipment repair for Senior Center building to include: Steam table, free standing steamer, ovens, freezers, refrigerators, dishwashers, ice maker, walk-in cooler/freezer, deep fryer, stove tops, stove top grill, grease trap, oven vents, etc. This quotation is for any unexpected servicing to the facility, and is only on an as needed basis. Request for pricing for any parts or large jobs may be further requested and further quotations may be solicited to ensure the best pricing for any work needed to be done in the facility.

Contractor shall exam the equipment; estimate total number of labor hours, total cost of material and provide a written quote to NFS for approval before repairing the equipment. If it takes multiple trips to repair the equipment, only one trip charge is allowed. The condition of all parts and equipment shall be new, the City will not accept any used or refurbished parts and equipment.

<u>Purchase of new equipment/parts</u>: In addition to the warranty clauses in City's standard Terms and Conditions, Contractor shall repair or replace any parts or equipment at no cost to the City for one year from City's acceptance for that parts or equipment.

1. This is an indefinite quantity and indefinite delivery Agreement for Services, which shall only be provided when the City chooses to move forward with a pending project and proper authorization

- and documentation have been approved. The City does not guarantee any minimum or maximum amount of Services will be requested under this Agreement.
- 2. Contractors must state the manufacturer of each product quoted on in conformity with the specifications.
- 3. All quotations must contain the quoting firm's name and be signed by an authorized agent, officer or employee.
- 4. Award will be made to the Contractor whose quotation is the most advantageous to the City.
- 5. Please attach your Quotation behind the <u>Exhibit A</u> cover sheet and submit this document to the address above.
- 6. Contractor shall provide the Services in accordance with a safety plan that is compliant with Occupational Safety and Health Administration ("OSHA"), American National Standards Institute and National Institute for Occupational Safety and Health standards. If, in the Contractor's sole determination, the Services to be provided do not require a safety plan, Contractor shall notify the City, in writing, describing the reasons a safety plan is unnecessary. The City reserves the right to request a safety plan following such notification.
