SUBJECT: Addendum #1 to Quote Request #35598 for Submersible Groundwater Pumps for Environmental Sampling

As a result of questions asked regarding Quote Request #35598, this Addendum is being sent. The Quotation Form is also being revised as Attachment 2-A, attached. If you would like the Quotation Form in Word, let me know.

**QUESTION:** Will these be dedicated or portable setups? No portable reel required? Specifically, the RediFlo 2's motor lead and tubing is requested as "installed".

**ANSWER:** These will be dedicated installation. No portable reel. Motor leads and tubing will be installed by the vendor.

**QUESTION:** Please let me know which model Rediflo3 pump is needed? Also, the motor lead kits come in 25' increments so please let me know the depths so we can quote accordingly?

**ANSWER:** The Model # for the Rediflow 3 is 10SQE10-260NE. If a per foot cost is not an option, please provide quote on the standard lengths of 25', 50', 75', etc. - referred to as "kit" on Quotation Form. Note: standard lengths have been added to the Quotation form. District staff will multiple the per foot by the standard lengths to arrive at total for applicable items if the standard lengths are not quoted..

The Rediflow 2 Model is **16E4**. For the Rediflow 2, Quote shall include cost for the **2" cooling shroud, Part #31735**.

Revised Attachment 2-A must be submitted. Attachment 3 - Affidavit as to Non-Collusion and Certification of Material Conformance; Attachment 4 - Qualifications Form - General; and Attachment 5 - Qualifications Form - Similar Commodity Sales, all remain the same and must be submitted as explained in original Quote Request 35598 document dated April 9, 2020.

**The District reserves the right to purchase any quantity on an as needed basis. Lengths of Motor Leads and LDPE Tubing not included on the quotation, will be quoted and negotiated by awarded vendor and District's Project Manager as needed.**
