**Addendum No. 2**

Please amend / revise / adjust the RFQ/P documents as follows....

1. Add following as last sentence under **Overview, (Page 1 of 10), 4<sup>th</sup> Paragraph:**
  - a. The selected CONTRACTOR'S agreement must include a Warranty as described herein.
  
2. Add the following new paragraph as a requirement under **Submission Content, (Page 7 of 10), after Cost Proposal:**
  - a. **Warranty**

The selected CONTRACTOR shall provide a minimum 2-year Warranty on workmanship and painting for each hydrant undertaken. The CONTRACTOR shall warrant the work for a minimum period of two (2) years after the date of acceptance for each hydrant against degradation, loss of corrosion protection, color, or gloss. At least one month before the end of the two-year Warranty period, a twenty-three (23) month inspection shall be conducted on each hydrant with the OWNER and CONTRACTOR. The purpose of this inspection shall be to identify and correct work which has become defective during the Warranty Period. The correction of such work shall be prompt and at the CONTRACTOR'S expense. Furnishing a Warranty exceeding this minimum will be considered favorably by the OWNER.
  
3. To avoid complications with email, Respondents should modify the following instruction found under **Submission Requirements and Due Date:**
  - a. Delete: *Email one (1) pdf version of the Response, no later than February 1, 2017 at 5:00 p.m. local time, addressed to the Owner Contact as listed above.*
  - b. Insert: *Upload one (1) pdf version of the Response, no later than February 1, 2017 at 5:00 p.m. local time, addressed to the Owner Contact as listed above to the Vendor Registry website.*



To submit (upload) a Response:

- a. Please visit to the Finance Page of the Oconee County Board of Commissioners website at [www.oconeecounty.com](http://www.oconeecounty.com)
  - b. One must be registered and logged on to Vendor Registry to submit (upload) a Response. (If you are already registered, please skip to step c.)
  - c. Please click the "Vendor Registration" link to the left-hand side of the page to complete the registration process. Once you have been emailed your login and password and completed the verification process, proceed to Step 3.
  - d. To login, visit the Vendor Registry, select "Quick Links" at the bottom right side of the Finance Page.

4. Written questions to the OWNER received via email before 5:00 pm, January 26, 2018 were as follows and are provided with responses for the benefit of potential RESPONDENTS.
- *Q: Will every hydrant be painted as a part of the inspection and maintenance activities?*
  - *A: Yes; we cite the RFQ/P, Task 4, Page 3 of 10.*
  - *Q: Will each hydrant be GPS'd or will this be required on only those that are recorded as new or previously unknown assets?*
  - *A: Yes; we cite the RFQ/P, Task 2, Page 2 and 3 of 10.*
  - *Q: Will there be an agreed upon data model before the project begins for the most effect import (sic) at the end of the project into the asset management platform?*
  - *A: The Qualification Based Selection process will consider value added features and benefits of each Respondent's Statement of Qualifications and Proposal.*
  - *Q: How many mils will be required on the hydrants that are painted?*
  - *A: This depends on the Respondent's overall quality assurance plan. The Qualification Based Selection process will consider value added features and benefits of each Respondent's Statement of Qualifications and Proposal. Also, please see Addition of Warranty in Items 1 and 2 above.*
