The work to be quoted consists of furnishing all materials, labor and equipment to: **Remove Existing and Furnish and Install Replacement AC Unit for Effingham County Prison Control Room**

Effingham County Board of Commissioners reserves the right to reject any and all quotes or any and all quotes that are non-responsive or not responsible. Effingham County may issue change orders altering the original scope of work to address changes or unforeseen conditions necessary for the project completion. No quotes shall be withdrawn within 60 days after the quote due date.

Prison Rape Elimination Act (PREA):

One – 2.5 ton heat pump with a new 14 seer condenser and air handling unit. (equal to or better than a 2.5 ton Carrier 14 SEER)

One – 10 KW Heater

One – Thermostat (equal or better than Honeywell TH5110D1006)

The existing line set can be re-used and flushed to remove incompatible oil residue.

All electrical and controls to be reconnected and made operational.

Vendor to provide details on manufacturer warranty on parts and equipment along with all documentation for registration.

Vendor to provide details on vendor warranty on labor and parts.

The contractor shall be responsible for obtaining all permits as required to perform the work. Additionally, all equipment and personnel required to perform the work shall be provided by the contractor. The contractor will not utilize any of Effingham County's equipment or personnel to perform the work.

The contractor shall at all times guard against damage or loss of Effingham County property or the general public and shall be held responsible for replacing or repairing any loss or damage to the satisfaction of The Effingham County Board of Commissioners.

ACKNOWLEDGEMENT STATEMENT
